Agenda Item: Chair's Report

Discussion: Mr. Aulbach updated members:

- On the status of the Revised Total Coliform Rule (RTCR). The proposed rule language is consistent with the federal rule which allows it to go through the exempt process. He plans to send to EPA for comments before the NOIRA. The RTCR will be included in the full regulations revision and thus be included in the APA process at that time. A review team, headed by Bennett Ragnauth, is conducting an internal review and any changes will go to the RAP.
- That budget cuts became effective July 1, 2015. ODW financial support of 16 DCLS courier sites was eliminated. Three FTEs were also eliminated in the consolidation of the ECFO to CFO and SEVFO. All impacted employees accepted vacant positions within ODW.
- That there is concern that the salary range of environmental inspector staff plays a role in the turnover rate. Brian Blankenship will be project leader in exploring career path alternatives for the inspector staff.
- That the Pamunkey Indian Tribe received federal recognition. Steve Pellei will liaise with the tribe. If a waterworks is located in the reservation once tribal lands are defined, jurisdiction belongs to the federal government.
- That the City of Danville and Halifax County Service Authority have had taste
 and odor problems since February. The City began feeding powdered activated
 carbon and the service authority had to install feeders before treating with PAC.
- That CDC has a new target concentration of 0.7 mg/L for fluoride. One waterworks is considering stopping fluoridation over budget concerns. Mr. Crocker commented that since the new target concentration is 30% less than the previous, that it would effectively reduce chemical costs by 30%.

Mr. Anderson stated that the additional sampling of water provided by the City may be problematic once the races begin and vehicle access is restricted. SE-RCAP is working with VA AWWA to provide training under an EPA Training and Technical Assistance Grant to Assist Small Drinking Water Systems,

 Water Control Board (HB 1871) went into effect on July 1, 2015. DEQ and
 VDH collaborated to develop a unified form. Online registration has been
 tested in-house.

requests backlogged from last year. SE-RCAP received approximately \$500,000 from the Virginia Department of Social Services for the Community Services Block Grant. SE-RCAP provides training and technical assistance to localities and on needs assessments, engineering studies, and planning with regard to water and wastewater problems with most awards under \$100,000. SE-RCAP is helping one community with a failing storage tank and helping a MHP and another privately

owned waterworks in connecting to local service authorities.

Discussion:

Mr. Dewhirst restated that VA AWWA is collaborating with SE-RCAP to provide training to operators from small waterworks to be held at a location in Southwest Virginia. The theme for the 2015 WaterJAM is Going Green. Dates for the JAM are September 14-17. In October, VA AWWA is offering a customer service workshop in Newport News. He also proposed that the industry look at the Professional Operator designation as a way to make skills transferable and allow for the recognition of professional credentials that may increase earning potential and expand job opportunities.

Agenda Item: New Business

Discussion:

- Mr. Pellei reported that EPA is still emphasizing that states reduce their unliquidated obligations. ODW submitted its 2015 DWSRF grant application on June 1, 2015. After the application was submitted, EPA informed Virginia that the grant was reduced from \$14.6 million to \$14.5 million. It appears that for 2016, the Drinking Water SRF will decline from \$900 million to \$700 million nationally, If this reduction holds true, Virginia could see a \$2 to \$2.5 million reduction in its SRF. For 2016, ODW offered \$24 million in construction funds. Mr. Pellei revisited that signage is required on the construction site that EPA funds are being used. He concluded with announcement that the project engineer vacancy in Abingdon had been filled.
- Mr. Aulbach provided insight into a recent visitation policy change (and no photographs allowed) at a service authority that would hinder ODW staff in making arrangements to conduct sanitary surveys. The policy is being reassessed by the survey authority's board. He also relayed that an engineer in LFO just passed his PE exam and that ODW is assisting a new ADE in LFO with getting an advanced degree from Virginia Tech.
- Mr. Anderson asked members to provide organizational input on training gaps to be discussed at next Spring's Operator Certification Stakeholders' Meeting. With projected budget cuts, ODW wants to ensure that the most needed offerings are retained. Emphasis is to retain those offerings that cannot be replicated by the industry, such as the hands-on training at a surface water treatment plant and the distribution system courses.
