	for Virginia to consider similar changes. I think this is worth discussing and therefore; it has been added to the	
	agenda. We may want to consider a small taskforce to address the proposed changes that make sense for Virginia. Finally, welcome to Dr. Jay Collins as the Level I Representative as a replacement for Dr. T. J. Novosel".

Trauma System Plan Task Force Update – Dr. Calland:	 Dr. Calland stated that he is pleased to report that the Commonwealth of Virginia Trauma System Plan was approved by the Task Force today with one modification. As noted during the last meeting, we would like to move to an integrated, inclusive, and diverse Advisory Board that is well represented by experts who are experienced in the care of the patient from injury prevention to rehabilitation and everything in between. A motion was made by Andi Wright to approve the Commonwealth of Virginia Trauma System Plan and move it forward to the Advisory Board. Emory Altizer seconded the motion. There were no abstentions or oppositions. The motion passed. (Applause) Dr. Calland stated that this is a big deal. He loves how the task force have put the patient first on this project and have worked together so cordially. Great job everyone. He thanked everyone for his or her time and engagement on this.

Old/Unfinished Business:	 a) Nominations to fill open committee seats Per Tim, the Non-Trauma Center Representative seat is vacant. Adam Rochman is a member of the TPIC and we need a formal nomination today to accept him for the Non-Trauma seat. Dr. Jay Collins made a motion to nominate Adam Rochman for the Non-Trauma Center Representative seat on the Trauma System Oversight & Management Committee. Lou Ann Miller seconded the motion. There was no discussion. All committee members were in favor of the motion. There were no abstentions or oppositions. The motion passed. Dr. Calland stated that the committee might need to consider another Rehab Representative. He asked the committee to think about nominees for that position as we transition to the new committee structure. 	

	On another note, Lou Ann Miller asked about the Trauma Performance Improvement Committee (TPIC).
	Since Dwight is no longer at OEMS, what is the future of TPIC? Tim stated that OEMS is hoping to bring
	in two epidemiologists, with one starting later this month. Stay tuned, we plan to get back on track.
New Business:	a) New Trauma Center Site Reviewers
	Tim stated that this is an informational item. There was a call for additional site reviewers, particularly,
	emergency medicine physicians. We have two new Surgeon/Team Leaders: Dr. Jeff Haynes of VCU
	(Peds) and Dr. Ranjit Pullarkat of Reston (Level II). We also have four new Emergency Medicine
	Reviewers: Dr. Kevin Broyles of Carilion Roanoke Memorial (Level 1), Dr. Michael Vitto of VCU
	(Level 1), Dr. Saad Amin of Reston Hospital (Level II) and Dr. David Jacobs of Reston Hospital (Level
	II).
	b) ABMS Maintenance of Certifications and physician trauma CME
	Dr. Calland stated that CME requirements have been done away with for physicians that are being verified
	under the American College of Surgeons (ACS) verification process. The TMD (Trauma Medical
	Director) and the Pediatric TMD still have to meet the requirements. Everyone else has to maintain board
	certification. This is a huge change. The idea for the Commonwealth is that we should make our state
	requirements for Trauma Center Verification more in line with the ACS COT. And Wright stated that the
	Commonwealth has been verifying and designating trauma centers probably for over 30 years now and
	have always used the ACS optimal treatment of the injured patient as a template. However, just because
	the ACS changes something, it does not automatically translate to the state. If it is the will of this
	committee for it to go forward, it still needs to go the Advisory Board and the Board of Health before any
	changes can take place. She is interested in what Dr. Hickey has to say concerning this as an emergency
	medicine physician. Dr. Hickey feels that this needs to be adopted in Virginia. And stated that it is really
	about patient outcomes and providing good patient care. Tim stated that Trauma Manual Review is part of
	the Acute Care Committee Objective 1.1 and the CME will be updated there. The group discussed this
	matter how this change affects Nurse Practitioners (NP) and Physician Assistant (PA). It was decided that
	a workgroup should be established to further discuss the CME changes and the language. The workgroup
	should include trauma surgeons and trauma program manager.
	A motion was made by Andi to assemble a task force to address the changes of the ACS CMEs and
	how the changes affect the Commonwealth. Dr. Jay Collins seconded the motion. There was no
	discussion. All committee members were in favor of the motion. There were no abstentions or
	oppositions. The motion passed.
	Once the shanges are made I as Ann extend how long it would take before they so into the Trauma
	Once the changes are made, Lou Ann asked how long it would take before they go into the Trauma
	Designation Manual. Tim stated that they would have to be approved by the Advisory Board and the State
	Board of Health, so it depends when it can go on their agenda. Essentially, it may take about a year.
	A motion was made to appoint Andi Wright as the chair of the task force. Dr. Hickey seconded the
	motion. There was no discussion. All committee members were in favor of the motion. There were
	no abstentions or oppositions. The motion passed.
	Other members of the task force will include Dr. Stephenson, Dr. Collins and Dr. Hickey. They also need

	at least one nurse practitioner or PA from each Level on the task force. And i will send out an email to all of the Trauma Program managers so that they can recommend a NP or PA from their facilities.	
	c) Trauma System Plan Implementation/Assembling of the new Committee Membership Dr. Calland asked for input about implementing the Plan. Gary Brown stated that there is no need to wait until the By-Laws are officially revised and approved. You can start where you feel comfortable. Cam stated that since this new plan involves new members that have not been a part of the system, such a rehab member, shouldn't we focus on the composition of the committees. At the next meeting, Dr. Calland suggested that the Task Force will meet to put together the membership of each committee and what their agenda should be. The Chair, Dr. Aboutanos, would be appointing members for each committee.
