- No cost extension for 1506 has been granted
- Two Comprehensive Harm reduction running sites
 - o Wise county
 - Health Brigade
- Department of Behavioral Health is giving HIV Prevention money to purchase vans
- City council meeting regarding CHR in Roanoke, VA
- VDH submitted a legislative proposal to extend the Sunset clause
- PreP- Eric
 - Currently have 21 PreP sites
 - Added two new sites
 - Added a site in Petersburg
 - Added a site in Fredericksburg
 - \circ 61% of the clients on PreP will be included with Medicaid expansion
 - o Trainings-
 - Undoing Racism Training- 1 more for this year and will start more at the beginning on 2019

 - Seven slots available for unaligned Consumers. Need three from the EMA portion of Virginia.
 - Presentation of the Molecular HIV surveillance
 - Explanation of the toolkit. What is Molecular Surveillance?
 - How it is collected
 - How the transmission networks work
 - How the information will be used and how it is protected
 - Next Steps
 - Feedback on how to ensure public has a good understanding

 - There was a Consumer Training in Fredericksburg, VA and 45 Consumers attended
 - The topics that were covered were the ACA Ryan White Eligibility Medicaid Expansion and Back to Work and Housing in the Northwest Region.

- Trying to find resources for transgender men and women in northern Virginiaasking for resources
 - There is a survey of needs from UVA that will be statewide- hoping this survey will determine the exact needs on the transgender community.

Shawn Buckner-

- Arlington County has been experiencing budget cuts due to the Medicaid expansion and decrease in funds from the State
- MOU has been approved and the BHD will be providing HIV testing at offsite locations, such as treatment facilities, Detox, and community events
- o Received a grant to hire 2 part-time Peer Recovery Specialist for 2 years

- The VHARCC/ MA AETC RP at VCU held Benefits 101 training in Glen Allen Oct 9-10. Partners from DBDHS, DMAS, DSS, Disability Determination office, SSA, and SOAR provided training on Medicare, Medicaid, SSI/SSDI/SOAR, SNAP, TANF, WIC and other social welfare programs. Over 30 medical and non-medical case managers attended. VCU is hoping to offer the course again in March.
- The MA AETC is completing its application for continued funding through Ryan White Part F. As a part of this application process, we are seeking Letters of Support from community partners to submit with the application. Our application is due Nov 18th. If your agency has benefited from the services provided by the AETC and would like to submit a letter, please email Robert.rodney@vcuhealth.org.
- Motivational Interviewing is close to being complete for case managers statewide. VDH has requested the program be expanded and offered to CHARLI case managers. That course will be coming after the New Year.

Medicaid Expansion-

- Safere Presented on the 2019 Medicaid Expansion and the eligibility requirements
 - Care will be available to an additional 400,000 people
 - There is no work requirement for first year of expansion according to DMAS.
 VDH will be seeking exemption for People living with HIV and TB.
 - ACA Open Enrolment November 11th through December 15th
 - Medicaid Enrollment- October 15th through December 7th

Discussion of Workgroup effectiveness-

- Wanting Health Disparities to touch base on the transgender community
- Have more subgroup meetings- every meeting
- People are more involved in small groups vs. the quarterly meeting
- Overall purpose to be stated
- Have set chairs for each workgroup
- Subcommittees
 - o Drug user health

 - Health Disparities
 - Monitoring and evaluation
- Transportation can be provided with Ryan White funds to get clients to support groups
