## COMMONWEALTH OF VIRGINIA VIRGINIA GAS AND OIL BOARD HEARINGS MINUTES MARCH 18, 2014

Diane Davis brought up the matter of combining the previously approved -02 and -03 into an -05 to correct all matters existing with this order for docket 91-1119-0161. She also stated that an -04 was pendiing which would be processed after this action. Anita Duty with CNX agreed and the Board approved the -05.

11. The Board will review the February 2014 minutes for approval.

The petition was Approved. Majority vote for approval was given.
