After Chairman Tom DePonty's welcoming remarks, Authority Board members provided introductions.

VIRGINIA NUCLEAR ENERGY CONSORTIUM 03/06/19 Draft Meeting Minutes:

After brief review, Gene Grecheck requested a motion to approve 03/06/19 meeting minutes. Woody Lawman seconded. The motion carried unanimously.

Joshua Saks, Deputy Secretary of Natural Resources

- Briefed the authority on the administration's current carbon mitigation initiatives (CMI) welcoming an open dialogue with the authority.
- Authority requested suggestions for making nuclear a part of the CMI discussions stressing it's important role in these initiatives.

VNEC UPDATE- April Wade:

- Briefed authority on meeting with Governor and Secretary Ball. Discussed at length the Energy Plan and Authority's disappointment that recommendation regarding nuclear not included. Stressed we must stay in forefront of these discussions with climate change and how nuclear is a source to combat GHG emissions.
- 17th Energy Cluster legislation passed. \$80,000 budgeted to implement plan. Virginia

now fifth state to include energy cluster. Discussed how nuclear plays a vital role in the workforce and must be included in the development.

- Putting summit together occurring later this summer as a platform for this discussion.
- Matt Kellam from Virginia Energy Workforce Consortium (VEWC) currently compiling the workforce demand and talent supply data and in the early planning stages with the college system and the Virginia Department of Education.

NUCLEAR NEWS – Chairman DePonty

• In energy news, Exelon announce May 8 that it will shut down Three Mile Island Nuclear Generating Station's Unit 1 reactor. This news has a negative economic impact to Virginia. Planning and design for an effective and efficient replacement capacity is important and takes time. With a shutdown of this magnitude, replacement capacity will almost definitely be fossil fuels, which will have a negative impact on the GHG emission reduction policies.
