Subject matter and intent

The Board for Barbers and Cosmetology (the Board) seeks to amend its current regulations governing tattooing and body-piercing to ensure they are as least intrusive and burdensome as possible, while still protecting the health, safety, and welfare of the public. The regulations will be reviewed to make sure that they accurately reflect current professional and industry standards and are consistent, clearly written, and easily understandable.

The Board will also consider amending current regulations to allow the tattoo and body-piercing apprenticeships to be administered by the Virginia Department of Labor and Industry. The Board may make other changes it identifies as necessary during the regulatory review process.

The regulations shall not be in conflict with the purposes and intent of this chapter or of Chapters 1 (§ $\underline{54.1-100}$ et seq.) and 3 (§ $\underline{54.1-300}$ et seq.) of this title."

Purpose

Changes in the body art industry, and the time elapsed since the last regulatory changes, warrant review. The Tattooing Regulations have not been amended since their initial promulgation in 2006 (other than purely fee-related changes). Several sections appear appropriate for being brought into alignment with other Board-regulated professions to reduce the regulatory complexity for tattooers and body-piercers without compromising the health, safety, or welfare of the public.

Additionally, the Board believes that allowing the tattoo and body-piercing apprenticeships to operate under the Virginia Department of Labor and Industry will provide a more standardized apprenticeship, improve training and minimum competency, and ensure apprenticeships are conducted in compliance with state and federal labor laws. Reviewing the regulations for clarity will facilitate increased compliance and, ultimately, better protection of the public's health, safety, and welfare.

Substance

The intent of the general review of existing tattooing and body-piercing regulations is to improve clarity; ensure consistency with current professional and industry standards; and minimize regulatory burdens. The Board will strive to ensure any changes are as least intrusive and burdensome as possible, while protecting the public's health, safety, and welfare.

The Board will also consider amending current regulations to allow the tattoo and body-piercing apprenticeships to be administered by the Virginia Department of Labor and Industry. Other changes which may be necessary may also be considered.
