The Board is amending Section 180 of regulations governing the practice of dentistry and dental hygiene to correct the dates in two documents incorporate by reference. A new edition of the publication "Current Dental Terminology" is valid for 2007-2008, rather than the 1995-2000 edition cited in subsection E; and the date of October 2001 should be cited for the Requirements for Recognition for Dental Specialties and National Certifying Boards for Dental Specialists, rather than 1995.

Statement of final agency action

In accordance with the powers and duties of the boards, an amendment to 18 VAC60-20-10 et seq., Regulations Governing the Practice of Dentistry and Dental Hygiene was adopted by the Board on March 9, 2007. Although required to comply with the Virginia Register Act, the agency is exempt from provisions of the Administrative Process Act for the implementation of these regulations pursuant to § [2.2-4006](#) A 3.

§ [2.2-4006](#). Exemptions from requirements of this article.

A. The following agency actions otherwise subject to this chapter and § [2.2-4103](#) of the Virginia Register Act shall be exempted from the operation of this article:

1. Agency orders or regulations fixing rates or prices.
2. Regulations that establish or prescribe agency organization, internal practice or procedures, including delegations of authority.
3. Regulations that consist only of changes in style or form or corrections of technical errors. Each promulgating agency shall review all references to sections of the Code of Virginia within their regulations each time a new supplement or replacement volume to the Code of Virginia is published to ensure the accuracy of each section or section subdivision identification listed.
