This regulations section provides for the hunting of fox squirrels in those counties west of the Blue Ridge as well as select counties in the eastern foothills of the Blue Ridge. Based upon observational data indicating expansion of the fox squirrel's range into additional counties, this action adds Henry County to the list of counties where fox squirrels may be hunted.
