This regulatory action is to update the requirements for local code academies to reflect current practices of the Jack A. Proctor Virginia Building Code Academy for consistency in the operation of the state and local academies and to clarify reporting and assurance requirements for the local academies to ensure compatible courses and practices.

The statutory authority for the establishment of the regulations for individual and regional code academies is § 36-137(7) of the Code of Virginia as a power of the Board of Housing and Community Development where individual and regional code academies may be accredited by the Department to retain a 2% levy on building permit fees which would otherwise be used by the Jack A. Proctor Virginia Building Code Academy.

As the nature of the construction industry changes, new technologies are present and the building and fire codes affecting the construction and use of buildings and structures evolve, there is a need for code academies to address the changing environment and be consistent with the instruction methods and course material used by the Jack A. Proctor Virginia Building Code Academy. As local academies are accredited by the Department of Housing and Community Development, the regulations for accreditation of the local academies must reflect the most current methodologies and instructional practices for consistency with the state code academy.

As accreditation of local academies is required by statute to enable the 2% fee levy on building permit fees collected by local building departments to be retained in those localities which chose to have a local or regional code academy, the Department believes that updating the accreditation standards to reflect current practices of the state code academy is the best alternative available for assuring consistency in the delivery of training and instruction for Virginia code enforcement personnel.
