The state regulations affected by this action are FAMIS Eligibility Requirements (12 VAC 30-141-100) and FAMIS MOMS Eligibility Requirements (12 VAC 30-141-740).

Currently, individuals eligible for FAMIS and FAMIS MOMS must be either a U.S. citizen, U.S. national, or qualified noncitizen. U.S. citizens and nationals may establish that they meet this eligibility requirement by submitting a written declaration of citizenship or nationality as required by § 1137(d) of the *Social Security Act*. Individuals eligible for Medicaid must provide documentary evidence of citizenship or nationality and documentation of personal identity in addition to the written declaration. Currently, documentary evidence is not required for eligibility under FAMIS and FAMIS MOMS.

This action implements a mandate in Section 211 of the Children's Health Insurance Program Reauthorization Act (CHIPRA) of 2009 (Public Law 111-3) that applies the Medicaid citizenship

verification requirements to the Children's Health Insurance Program (CHIP). Upon implementation of this regulation, FAMIS and FAMIS MOMS applicants will be required to provide documentary evidence of citizenship or nationality and documentation of personal identity in order to meet the citizenship eligibility requirement unless otherwise exempt. CHIPRA also gives states an additional option for meeting this requirement through an agreement with the Social Security Administration.

Section 2105(c) of *Social Security Act* (42 U.S.C.1397ee(c)) is amended by adding the following new provision, effective January 1, 2010:

#### (9) CITIZENSHIP DOCUMENTATION REQUIREMENTS.—

(A) IN GENERAL.—No payment may be made under this section with respect to an individual who has, or is, declared to be a citizen or national of the United States for purposes of establishing eligibility under this title unless the State meets the requirements of section 1902(a)(46)(B) with respect to the individual

Section 1902(a)(46)(B) as amended by CHIPRA reads as follows:

- (B) provide, with respect to an individual declaring to be a citizen or national of the United States for purposes of establishing eligibility under this title, that the State shall satisfy the requirements of—
  - (i) section 1903(x); or
  - (ii) subsection (ee);

While Section 211 of CHIPRA has added more options for applicants seeking to establish nationality, DMAS must change its regulations to provide the choice of options to such applicants, *i.e.* the Agency has no discretion about adding the specified options into its regulations.

The *Code of Virginia* (1950) as amended, §32.1-351, grants to the Board of Medical Assistance Services the authority to administer and amend the Family Access to Medical Security Insurance Plan (FAMIS). The *Code of Virginia* (1950) as amended, § 32.1-351(K), authorizes the Director of DMAS to administer and amend the Family Access to Medical Security Insurance Plan according to the Board's requirements. The federal Children's Health Insurance Program (CHIP) as established by § 2101 of the *Social Security Act* [42 U.S.C. 1397aa] provides governing authority for payments for services.

This action meets the exemption provided by the *Code of Virginia* § 2.2-4006 (A)(4)(c) because it conforms 12VAC 30-141-100 and 12VAC 30-141-740 to the requirements of the federal statute which become effective January 1, 2010, and does not materially differ. Additionally, the Agency has no discretion concerning the implementation of this federal requirement.
