The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-270-10 et seq., "Pertaining to Blue Crab Fishery", establishing management measures, including season and bushel limits, for the 2023-2024 commercial crab fisheries.

### Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including marine fisheries regulations.

[Impetus] Results from the Bay-wide Winter Dredge Survey, as well as harvest results from the 2022 fisheries, indicate the Chesapeake Bay blue crab stock is currently not overfished and overfishing is not occurring, but total abundance and juvenile abundance are at low levels while exploitation is somewhat elevated. Management of blue crabs is updated on an annual basis, where bushel limits are effective from July 5th of one year to July 4th of the next and an evaluation of the winter dredge season is conducted annually. While staff recommends maintaining the low bushel seasons from last year, a change to the low bushel limit is also proposed.
