The Board reviewed the education provider audit reports submitted by staff. These were the first two audits completed after the development of procedures and documentation by staff. The Committee recommends that the procedures and forms be adopted as recommended, but that the process be carefully monitored by the Committee on a regular basis and that modifications to the forms and procedures be completed as required. After discussion, a motion was made by **Mr. Kirby** and seconded by **Mr. Redifer** to adopt the Committee's recommendations. The motion was approved unanimously. **Members voting "yes" were: Kinser, Kirby, Miller, Modisett, Rackas Pate, Redifer, Smith, Tomlin, Walton and Wood.**

C. Education Provider Training

The Board reviewed the recommendation of the Committee that would require education providers, as a prerequisite to approval, attend a scheduled training class provided by staff. This would be mandatory for ALL training providers with failure to attend the training resulting in the suspension of their approval as providers. The Board determined that they did not have the authority to require existing providers to attend the training so they could not make it mandatory. The idea of provider training itself, however, was approved and the Board directed staff to develop the training to be used on a voluntary basis.

D. Provisional Approvals

The Board adopted the Committee recommendation that provisional approvals be discontinued.

E. Water Well Vocational Training

After discussion, a motion was made by **Mr. Walton** and seconded by **Mr. Kirby** to adopted the Committee's recommendation that requires the vocational training program being developed for water well system providers be comprehensive in nature and that specific course curriculum be reviewed by the Board as needed. This was the result of an

issue that was brought to the Committee by the Virginia Water Well Association that wanted to find a way to have the majority of classes offered at their annual conference and regional "Jubilee" be independently considered for meeting the 48 hour education requirement. In keeping with the requirements of all of the other approved vocational education programs, the Board wants the curriculum to be submitted for approval in a block, not as 12-48 individual classes. The motion was approved unanimously. **Members voting "yes" were: Kinser, Kirby, Miller, Modisett, Rackas Pate, Redifer, Smith, Tomlin, Walton and Wood.**

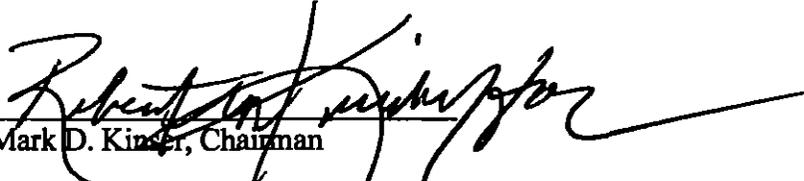
3. Mr. Redifer notified the Board that the updates to the Virginia Uniform Statewide Building Code will become effective on May 1, 2008.

4. The Board discussed the issues that have come up in the certification of water well system providers that are sole proprietorships and the difficulty they have in obtaining work experience under the direct supervision of a certified master water well system provider. This appears to have been an item issue that was not anticipated during the development of the statutes. Since this is a statutory issue it will take a statutory solution. The Virginia Water Well Association is aware of the problem and it should be addressed at the next session. Until then, the Board will look at alternative methods of documentation that can be used, such as those currently in place and used for tradesmen licenses. This will still not likely be a solution that is applicable to all of those affected by the statutes.

Their being no further business to come before the board, the meeting was adjourned at 12.40 P.M. upon a motion by Mr. Kirby and seconded by Ms. Wood. **The motion passed by unanimous vote. Members voting yes were: Kinser, Kirby, Miller, Modisett, Redifer, Smith, Rackas Pate, Tomlin and Walton and Wood.**
