Public Comment

In the matter of **File Number 2012-02892, Sunset Memorial Gardens Subsidiary, Inc.**, the Board reviewed the Consent Order as seen and

agreed to by Sunset Memorial Gardens Subsidiary, Inc. A motion was made by Ms. Garland and seconded by Mr. Minter to accept the proposed Consent Order offer wherein Sunset Memorial Gardens Subsidiary, Inc., admits to a violation of 18 VAC 47-20-190.13 (Count 1) of the Board's 2000 Regulations, and agrees to a monetary penalty of \$2,500.00 for the violation contained in Count 1, and \$150.00 in Board costs, for a total of \$2,650.00. In addition, the Board shall waive \$2,000.00 of the monetary penalty for Count 1, due to Sunset Memorial Gardens Subsidiary Inc.'s agreement to provide to the Complainant's satisfaction, over \$15,000.00 in merchandise and services. The motion passed unanimously. Members voting "Yes" were Garland, Gilliam, Lundy and Minter.

In the matter of **File Number 2013-00445, Holston View Cemetery Development Company Incorporated**, the Board reviewed the Consent Order as seen and agreed to by Holston View Cemetery Development Company Incorporated. A motion was made by Ms. Garland and seconded by Ms. Lundy to accept the proposed Consent Order offer wherein Holston View Cemetery Development Company Incorporated, admits to 2 violations of §54.1-2324.A of the *Code of Virginia*, and agrees to a monetary penalty of \$1,500.00 for each violation contained in Count 1, and \$150.00 in Board costs, for a total of \$3,150.00. In addition, the Board shall waive \$1,000.00 per violation, for a total of \$2,000.00, if Holston View Cemetery Development Company Incorporated submits both the 2010 and 2011 financial, including audit by a Certified Public Accountant, to the Board within ninety (90) days of the effective date of the order. Failure to comply with the terms of the order will result in the suspension of Holston View Cemetery Development Company Incorporated's license until such time as the 2010 and 2011 financial reports have been submitted to the Board. The motion passed unanimously. Members voting "Yes" were Garland, Gilliam, Lundy and Minter.
