Reinstatement Applicant
Case No.: 144878** Ms. Kessel appeared without counsel to discuss her Reinstatement Application for Licensure to practice dental hygiene in the Commonwealth of Virginia, and the allegations set forth in a Notice of the Board dated June 15, 2012. The Committee received statements from Ms. Kessel and discussed the allegations with her.
- Closed Meeting:** Ms. Pace moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Sharon J. Kessel. Additionally, Ms. Pace moved that Ms. Reen, Ms. Lee and Ms. Roukous attend the closed meeting because their presence in the closed meeting is deemed necessary and their presence will aid the Committee in its deliberations. The motion was seconded and passed.
- Reconvene:** Ms. Pace moved that the Committee certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and passed.

Ms. Roukous further reported that if Ms. Kessell does not complete and submit documentation of passage of a regional clinical examination in dental hygiene acceptable to the Board within 12 months from the date of entry of the Order, her Reinstatement Application for Licensure to practice dental hygiene will be denied.

Ms. Pace moved to adopt the decision of the Committee. The motion was seconded and passed.
