

**VIRGINIA BOARD OF NURSING

**ESTABLISHMENT OF  
A QUORUM:** With five members of the Board present, a quorum was established.

**FORMAL HEARINGS:** **Anthonette Dillard, LPN 0002-033448**  
Ms. Dillard appeared, represented by K. Dane Mills, attorney.

Anne Joseph, Deputy Director, Administrative Proceedings Division, represented the Commonwealth. Mr. Casway was legal counsel for the Board. L. Kim Taylor, court reporter with Farnsworth & Taylor Reporting, recorded the proceedings.

Kim Martin, Senior Investigator, Department of Health Professions; Alesia Baskin, Administrative Assistant, Board of Nursing; and Francine Greer, Administrative Assistant, Board of Nursing were present and testified.

**CLOSED MEETING:** Ms. Lindsay moved that the Board of Nursing convene a closed meeting pursuant to §2.2-3711(A)(27) of the *Code of Virginia* at 10:36 A.M., for the purpose of deliberation to reach a decision in the matter of Ms. Dillard.
