MINUTES

Meeting Called to Order

The meeting was called to order at 9:19 a. m. by Chairman Rick Clark. Board Clerk Stephanie Morton called the roll and a quorum of members was present.

Acceptance of Meeting Minutes

On a motion made by Charles Ciccotti, and seconded by Gilbert Smith, the draft minutes from the December 12, 2013 meeting were approved unanimously.

Acknowledgments

The new Agency Director, Fran Ecker was in attendance at the meeting and was offered an opportunity to introduce herself and address the Board and the meeting attendees. Ms. Ecker stressed the importance of the department's commitment to law enforcement professionalism and training.

Old Business

There was no new business discussed.

New Business

Report of the Law Enforcement Curriculum Review Committee – Performance Outcome 7.4

The Law Enforcement Curriculum Review Committee is suggesting approval to revise Performance Outcome 7.4 of the Compulsory Minimum Training Standards for Law Enforcement Officers by adding three new courses of fire that focus on short range engagement and removing the requirement of the Virginia Modified Double Action Course.

These revisions were sent by DCJS staff to constituents March 24, 2014 and the public comment period ended May 24, 2014. During that period, the only comments received were in favor of the proposed recommended changes.

On a motion made by Carol Adams and seconded by Charles Ciccotti, the Committee voted to revise Performance Outcome 7.4. The motion was unanimously approved by vote.

Regulations Relating to Private Security Services

The Department is requesting approval to amend the style and format of the current regulations and to proceed with regulatory edits to conform to upcoming changes in the Virginia Code. There are two separation actions for Regulations Relating to Private Security Services that need to be revised. During the last General Assembly, the language in the Code of Virginia was mended that now allows the Board to give full training exemptions. In order to conform to the new code requirements, the Department will need to amend the applicable current regulation by removing the word "partial". The Department is also requesting to restructure this chapter, by repealing the current regulations, and replacing them with three individual chapters affecting businesses, training schools and registered personnel. Separating this

regulation is consistent with the Regulatory Reform Initiative. There is no change to any of the standards or requirements. It is simply a restructure of the regulation.

On a motion made by Charles Ciccotti and seconded by Gilbert Smith, the Committee voted to accept the recommended revisions. The motion was unanimously approved by vote.

Public Comment Periods

There were no public comments made during the comment period.

Next Meeting

The next meeting is scheduled for September 18, 2014 at 9:00 a.m.
