Case No.: 115138** Dr. Drake appeared with counsel, Amanda Kutz and Ben Pace, to discuss the allegations set forth in a Notice of the Board dated September 22, 2008. The Committee received statements from Dr. Drake, Ms. Kutz and Mr. Pace and discussed the allegations in the Notice with them.

Case No.: 117021** Dr. Massie appeared in accordance with a Notice of the Board dated October 31, 2008. The Committee received statements from Dr. Massie and fully discussed the allegations in the Notice with him.

**DECISION:
Case No. 117021** Ms. Ross reported that the Committee found Dr. Massie in violation of practicing dentistry without possessing a current, active, and valid license from April 1, 2006 through April 27, 2008.

The sanctions reported by Ms. Ross were that the Committee orders that Dr. Massie be issued a REPRIMAND and assessed a monetary penalty of fifteen thousand dollars (\$15,000). Also, Dr. Massie is required to complete the Virginia Dental Law Exam, 8 hours of continuing education in Ethics and 4 hours of continuing education in Risk Management within 6 months from the date of entry of the Order.

Dr. Hall moved to adopt the decision of the Committee. The motion was seconded and passed.
