**CLOSED SESSION:**

Upon a motion by Mr. Ahmad and duly seconded by Dr. Peck, the Board voted to convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Dr. Wald. Additionally, Mr. Ahmad moved that Mr. Casway, Ms. Chappell and Ms. Larimer attend the closed meeting, because their presence in the closed meeting was deemed necessary and would aid the Board in its deliberations.

**RECONVENE:**

Having certified that the matters discussed in the preceding closed session met the requirements of § 2.2-3712 of the Code, the Board reconvened in open session and announced its decision.

**DECISION:**

Upon a motion by Mr. Ahmad, and duly seconded by Dr. Van de Water, the Board made certain Findings of Fact and Conclusions of Law. Further, upon a motion by Dr. Stewart, and duly seconded by Ms. Leyva, the Board voted to continue Dr. Wald's license on indefinite suspension for not than less than eighteen (18) months from the date the Order is entered.

The vote was unanimous.
