#### THE VIRGINIA BOARD FOR ASBESTOS, LEAD, MOLD, AND HOME INSPECTORS **MEETING MINUTES**

The Virginia Board for Asbestos, Lead, Mold, and Home Inspectors met on November 10, 2010, at the offices of the Department of Professional and Occupational Regulation, Perimeter Center, 9960 Mayland Drive, Richmond, Virginia.

Mr. Cronan, finding a quorum of the Board present, called the meeting to order at 9:06 am.

Call to Order

Ms. Becker moved to approve the agenda. Mr. Marston seconded Approval of Agenda the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Hyatt, Loving, Marston, Palmer, and Varner. Board member Colleen Becker was present but did not vote because, by statute, she is ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Ms. Becker moved to approve the following minutes:

Ms. Daniels seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Hyatt, Loving, Marston, Palmer, and Varner. Board member Colleen Becker was present but did not vote because, by statute, she is ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Joe Crocket was present and addressed the Board.

Regarding File Number 2010-01870, John R. Rust, the Board members reviewed the record of the Informal Fact-Finding Conference, which consisted of the investigative file, transcripts and exhibits, and the Summary of the Informal Fact-Finding Conference. Mr. Rust, respondent; and Ms. Gresham, complainant, were present and addressed the Board. Mr. Varner moved to accept the Summary of the Informal Fact-Finding Conference as to the facts, which cites a violation of 18 VAC 15-40-190.6 (count 1) of the Board's regulations. Mr. Chapman seconded the motion which was approved by members: Atwood, Chapman, Daniels, Palmer, and Varner. Mr. Cronan and Mr. Loving voted in opposition of the motion. Mr. Hyatt abstained from the vote. Colleen Becker was present but did not vote because, by statute, she is ineligible to vote on matters unrelated to RRP until the effective date of the regulations. Mr. Marston was not present during the discussion or vote. The motion passed with a majority vote.

Mr. Varner moved to accept the Summary of the Informal Fact-Finding Conference as to the sanctions and impose a \$1,000.00 fine for the violation contained in Count 1. Mr. Hyatt seconded the motion which was approved by members: Atwood, Daniels, and Varner. The following members voted in opposition of the motion: Cronan, Chapman, Loving, and Palmer. The motion failed. Mr. Hyatt moved to amend the Summary of the Informal Fact-Finding Conference and imposed the following sanctions: probation for six (6) months. While on probation Rust must provide evidence acceptable to the Board of successfully completing a minimum of eight (8) contact hours of education

pertaining to structural inspection subject drawn from the building inspection content areas of the Board's examination, as well as a \$250 fine. If evidence of compliance is not received within six (6) months a monetary penalty of \$1,000 will be imposed. Mr. Palmer seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Hyatt, Loving, Palmer, and Varner. Board member Colleen Becker was present but did not vote because, by statute, she is ineligible to vote on matters unrelated to RRP until the effective date of the regulations. Mr. Marston was not present during the discussion or vote.

Regarding File Number 2011-00074, Fritz L. Montes, the Board members reviewed the application file, which consisted of the exhibits, transcript and the summary of the Informal Fact-Finding Conference. Mr. Montes was not present at the meeting. Mr. Hyatt moved to accept the summary of the IFF and approve Mr. Montes' lead inspector application. Ms. Becker seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Hyatt, Loving, Palmer, and Varner. Board member Colleen Becker was present but did not vote because, by statute, she is ineligible to vote on matters unrelated to RRP until the effective date of the regulations. Mr. Marston was not present during the discussion or vote.
