Ms. Harlow moved that the Board approve the minutes of its Approval of Board October 29, 2002 meeting as prepared by staff. Mr. Heppner Minutes seconded the motion, which was carried unanimously by six ave votes (Messrs. Bouldin, Nott, Heppner, Honeycutt, and Gerow; and Ms. Harlow). As Chairperson, Ms. Mentz did not vote.

Chairperson Mentz opened the floor for public comment. No Public Comment member of the public present expressed a desire to address the Period Board.

In the matter of File Number 2002-00883, Board v. Melvin W. File Number Edwards, the Board reviewed the record, which consisted of the 2002-00883 investigation file, transcript and exhibits from the IFF, and the presiding Board member's summary and recommendation. Melvin W. Edwards (Respondent) was not present, but was represented by his attorney, Thomas B. Kelly. Upon a motion by Mr. Nott and seconded by Ms. Harlow, the Board adopted the summary and recommendation, and revoked Melvin W. The presiding Board member, Mr. Crockett, was not present and did not participate in the discussion or vote. Lipps' Asbestos Supervisor license until he has completed another approved 40hour asbestos supervisor training course. The motion failed. Members voting "NO" were Mr. Honeycutt; Mr. Nott; Ms. Harlow; and Mr. Geller. Mr. Gerow votes "YES." Chairperson, Ms. Mentz did not vote. The presiding Board member, Mr. Crockett, was not present and did not participate in the discussion or vote. Mr. Bouldin and Mr. Heppner were present, but did not vote since by statute they are ineligible to vote on matters unrelated to home inspectors until July 1, 2003.

Members voting \$500.00. "YES" were Mr. Gerow; Mr. Honeycutt; Mr. Nott; Ms. Harlow; Mr. Geller; and Ms. Mentz. The presiding Board member. Mr. Crockett, was not present and did not participate in the discussion or vote. Mr. Bouldin and Mr. Heppner were present, but did not vote since by statute they are ineligible to vote on matters unrelated to home inspectors until July 1, 2003.

In the matter of File Number 2003-00772, Board v. Santos File Number Solano, the Board reviewed the record, which consisted of the 2003-00772 application file, transcript and exhibits from the IFF, and the presiding Board member's summary and recommendation. Santos Solano (Respondent) was not present. Upon a motion by Mr. Heppner and seconded by Mr. Nott, the Board adopted the summary and recommendation, and denied the Respondent's renewal application for Asbestos Worker based on the submission of a false social security number. In the matter of File Number 2002-01321, Board v. Avram Gold, the Board reviewed Consent Order Number 2003-0065, which was offered to and signed by Avram Gold (Respondent). Upon a motion by Ms. Harlow and seconded by Mr. Gerow, the Board made a counter offer to revoke Avram Gold's licenses for Asbestos Supervisor, Asbestos Inspector, Asbestos Management Planner, and Asbestos Project Designer and impose a monetary penalty of \$1,500 per license, totaling \$6,000. The Board gave the respondent 30 days to respond. The motion passed unanimously. Members voting "YES" were Mr. Gerow; Mr. Honeycutt; Mr. Nott; Ms. Harlow; Mr. Geller; and Ms. Mentz. Mr. Bouldin and Mr. Heppner were present, but did not vote since by statute they are ineligible to vote on matters unrelated to home inspectors until July 1, 2003.

In the matter of File Numbers 2002-03448, 2002-03408, 2002-03511, 2002-03351, 2002-03446, and 2002-03447, Board v. Charles Sledge, Jr., the Board reviewed the records, which consisted of the investigation file, transcript and exhibits from the IFF, and the presiding Board member's summaries and Charles Sledge, Jr. (Respondent) was not recommendations. present. Upon a motion by Ms. Harlow and seconded by Mr. Heppner, the Board adopted the summaries and amended the recommendations, and revoked Charles Sledge, Jr.'s licenses for Asbestos Supervisor, Asbestos Inspector, Asbestos Management Planner, Asbestos Project Designer, Asbestos Project Monitor, and Lead Inspector/Risk Assessor; and imposed monetary penalties of \$1,500.00 per license totaling \$9,000.00. David Dick informed the Board that the 2003 MAREC meeting, Staff Updates which will be hosted by Virginia, has been moved from January to March due to budgetary delays from EPA.

Joe Kossan told the Board that he has recently audited four new asbestos training courses offered by American Electric Power in Cleveland, Virginia.

Tom Perry informed the Board that on November 19 he reviewed the lead exam questions for all three disciplines as well as the state regulation section of the lead exam administered by Experior. Several questions were either corrected or deleted entirely. Experior will be holding a lead exam review workshop on March 19, 2003 and will need the assistance of several subject matter experts. Mr. Perry has recently audited two new lead training courses offered by Connor Environmental Services in Baltimore, Maryland. In January, he plans to audit two new lead training courses offered by Michael Baker Jr. Inc. in Virginia Beach.

Mr. Perry said that Kevin Hoeft from DPOR's enforcement division attended an EPA lead enforcement and compliance meeting in Arlington, Virginia on December 3-5. The meeting offered no new information or revelations from EPA.

The Board established its next meeting date to be March 25, 2003 Next Meeting Date at 9:00 AM in conference room 4W at DPOR.
