



Summary of the Informal Fact-Finding Conference

An Informal Fact-Finding Conference (IFF) was convened on May 1, 2003, at the Department of Professional and Occupational Regulation, pursuant to a Notice of Informal Fact-Finding Conference sent by certified mail to Gustavo Salinas Gusman on April 2, 2003. The following individuals participated at the conference: Gustavo Salinas Gusman, aka Gustavo Gusman-Salinas, Applicant; Lisa Salinas, Interpreter for Applicant; Douglas Schroder, Staff member; Jack A. Geller, presiding Board member.

Summation of Facts

- 1 On December 28, 2000, Gusman applied for and was issued an Asbestos Worker license (Number 3301-01228) using Social Security Number 219-88-0429
- 2 On December 10, 2002, Gusman applied for an Asbestos Worker license (Number 3301-021690) using Social Security Number 244-97-2077
- 3 Verification from the Social Security Administration verified Gustavo S. Gusman's correct Social Security Number to be 244-97-2077

Conclusion and Recommendation

After speaking with Mr. Gusman, and learning that he is current on his course refresher status, as well as having a valid Social Security Number for over two years, I strongly recommend that Mr. Gusman be approved as a Licensed Asbestos Worker.
