Summary of the Informal Fact-Finding Conference

An Informal Fact-Finding Conference (IFF) was convened on May, 6, 2004, at the Department of Professional and Occupational Regulation, pursuant to a Notice of Informal Fact-Finding Conference sent by certified mail to John Manganas, President of Manganas Painting Company, Inc., on March 26, 2004. The following individuals participated at the conference: John Manganas, Respondent; Rita Geary, Witness; Noelle B. Phillips, Investigator; Douglas W. Schroder, Staff Member; and Jack A. Geller, Presiding Board Member.

Summation of Facts

- 1. On September 24, 2002, Kevin Hoeft, Investigations Administrator for the Enforcement Division for the Department of Professional and Occupation Regulation, received information that Manganas Painting Co. Inc. (Manganas) was convicted of a felony in the United States District Court.
- 2. On or about August 27, 2002, in the United States District Court, Western District of Pennsylvania, violating Title 42, United States Code Section 6928(d)(2)(A). Manganas pled guilty to one felony count of Treatment, Storage, or Disposal of Hazardous Waste at a Facility That Does Not Have a Permit. (Title 42) No appeal is pending and Manganas' right to appeal has expired.
- 3. On or about October 28, 2002, Manganas told the Board's agent that he did not report the felony conviction.
- 4. During the IFF, Manganas testified that he did perform appropriate site clean-up after learning that an employee of Manganas Painting Co., Inc. improperly disposed of a regulated substance (lead) without Manganas' knowledge.

Conclusion and Recommendation

Count 1: 18 VAC 15-30-810(A)(6) (Effective October 1995)

Manganas' guilty plea, in United States District Court, Western District of Pennsylvania, violating Title 42, United States Code Section 6928(d)(2)(A), to one felony count of Treatment, Storage, or Disposal of Hazardous Waste at a Facility That Does Not Have a Permit. (Title 42), is in violation of Board Regulation 18 VAC 15-30-810(A)(6). No appeal is pending and Manganas' right to appeal has expired. Manganas made an honest error, without malicious intent and has paid more than his fair share in order to right the wrong doings performed by his former employee. Therefore, I recommend that no sanction be imposed.

Count 2: <u>18 VAC 15-30-810(A)(7)</u> (Effective October 1995)

Manganas' failure to report the felony within thirty days of conviction to the Board for Asbestos, Lead, and Home Inspectors is in violation of Board Regulation 18 VAC 15-30-810(A)(7). Therefore, I recommend that no sanction be imposed.
