Chairperson Heppner, finding a quorum of the Board present, <u>Call to Order</u> called the meeting to order at 9:00 am.

Ms. Harlow moved that the Board approve the agenda. Mr. Loving seconded the motion, which was unanimously approved by the following members: Heppner, Harlow, Honeycutt, Varner, Loving, Bouldin, Daniels, Hyatt and Sinyai. Ms. Hill was not present for the vote.

Adopt Agenda

Ms. Harlow moved that the Board approve the minutes of its November 2, 2005 meeting and the IFF minutes of January 5, 2006. Mr. Loving seconded the motion which was unanimously

Chairperson Heppner opened the floor for public comment. No **Public Comment** members of the public were present.

> File Numbers 2006-01216 and 2006-01218

Period

In the matter of File Number 2006-01216 and 2006-01218, Frederick L. Guest, the Board reviewed the record, which consisted of the application files, transcripts and exhibits from the IFFs and the presiding officers' summary and recommendation. Mr. Loving moved that the Board accept the summary and recommendation and approve the issuance of Mr. Guest's Lead Risk Assessor and Asbestos Inspector licenses after receipt and verification by DPOR staff of documentation that Mr. Guest has complied with the following terms of his February 7, 2005 Compliance Agreement with the United States Environmental Protection Agency:

- 1. The initial annual third party audit of EVE for compliance with all state and federal asbestos and lead abatement laws and regulations that was to have been completed by March 1, 2005;
- 2. Completion of a course on corporate ethics; and
- 3. Completion of asbestos and lead refresher courses every six months since Mr. Guest's last completion of asbestos and lead refresher courses in January, 2006.

Mr. Bouldin seconded the motion which was unanimously approved by the following members: Heppner, Harlow, Honeycutt, Varner, Loving, Bouldin, Daniels, Hyatt and Sinyai. Ms. Hill was not present for the vote.

Mr. Bouldin moved that the meeting be recessed and that the Board immediately reconvene in closed meeting for the purpose of consultation with legal counsel and briefings by staff pertaining to status of appeal litigation as permitted by § 2.2-3711.A.7 of the Code of Virginia. The following non-members will be in attendance to reasonably aid the consideration of the topic: Eric Gregory, Brian Hannigan, Karen O'Neal and David Dick. This motion is made with respect to the matter identified as agenda item VI. Mr. Loving seconded the motion, which was unanimously approved by the following members: Heppner, Harlow, Honeycutt, Varner, Loving, Bouldin, Daniels, Hyatt and Sinyai. Ms. Hill was not present for the vote.

Ms. Daniels seconded the motion which was approved by the following members: Daniels, Loving, Hyatt and Varner, Mr. Bouldin, Ms. Harlow, Mr. Honeycutt and Dr. Sinyai voted in opposition to the motion. Ms. Hill was absent. The motion passed with a majority vote.

David Dick advised the Board that the Governor's approval of the proposed amendments to the asbestos licensing and lead-based paint activities regulations was received on November 28, 2005. The Register filing was completed on December 8th with the public comment period beginning on January 9, 2006 and ending at 5:00 P.M. on April 14, 2006. The public hearing has been scheduled for March 30, 2006 commencing at 9:00 A.M. for leadbased paint activities and 11:00 A.M. for asbestos in DPOR's Conference Room 4 West.

David Dick reviewed the proposed EPA rule for lead; renovation, repair and painting program. The Board took no action.

Mr. Dick reviewed legislation which may be of interest to the Legislation Board that has been introduced in the 2006 Virginia General Assembly. No action taken by the Board.

In the absence of Joseph Kossan, David Dick provided the Board Other Business with an update on the training program audit activity.
