## **MEETING MINUTES**

Chairperson Heppner, finding a quorum of the Board present, <u>Call to Order</u> called the meeting to order at 9:03 am.

Mr. Cronan moved that the Board approve the agenda. Mr. Adopt Agenda
Loving seconded the motion, which was unanimously approved
by the following members: Heppner, Daniels, Varner, Loving,
Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms.
Hill were not present for the vote.

Mr. Varner moved that the Board approve the minutes of its Approval of Board August 22, 2007 meeting and the IFF minutes of August 23, Minutes

2007, September 21 and 27, 2007 and the IFF minutes from October 4, 2007. Mr. Loving seconded the motion which was unanimously approved by the following members: Heppner. Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

Chairperson Heppner opened the floor for public comment. No Public Comment person present asked to address the Board.

In the matter of File Number 2007-02491, David Lawrence File Number Perrin, the Board reviewed the record which consisted of the 2007-02491 complaint file, transcript and exhibits from the IFF and the presiding officer's summary and recommendation. David Lawrence Perrin (Respondent) was not present.

Upon a motion by Mr. Howard and seconded by Mr. Sinyai, the Board found Mr. Perrin in violation of both counts. The motion was unanimously approved by the following members: Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan, Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

Upon a motion by Mr. Hyatt and seconded by Mr. Cronan, the Board fined Mr. Perrin \$100 per count for a total fine of \$200. The motion was unanimously approved by the following members: Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

In the matter of File Number 2008-00401, Leroy Macbeth File Number Shecut Jr., the Board reviewed the record which consisted of the 2008-00401 application file, transcript and exhibits from the IFF and the presiding officer's summary and recommendation. Leroy Macbeth Shecut Jr. (Respondent) was present and addressed the Board.

Upon a motion by Mr. Hyatt and seconded by Mr. Cronan, the Board adopted the summary and recommendation and approved the application for Asbestos Supervisor license for Leroy Macbeth Shecut Jr. The motion was unanimously approved by the following members:

Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

In the matter of File Number 2007-05161, Staige L. Miller, the File Number Board reviewed the record which consisted of the application file, 2007--05161 transcript and exhibits from the IFF and the presiding officer's summary and recommendation. Ms. Miller (Respondent) was not present.

Upon a motion by Mr. Hyatt and seconded by Ms. Daniels, the Board adopted the summary and recommendation and approved the application for Lead Inspector license for Staige L. Miller under the provisions of 18 VAC 15-30-41 of the Board's regulations. The motion was unanimously approved by the following members: Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

The Board decided to vote on these two cases as one block File Numbers without dissent. In the matter of File Number 2008-00263. Johnathan Lee Northern and File Number 2008-00928 Raymond Maurice Richardson, the Board reviewed the record which consisted of the application file, transcript and exhibits from the IFF and the presiding officer's summary and recommendation. Mr. Northern and Mr. Richardson (Respondents) were not present.

Upon a motion by Mr. Varner and seconded by Mr. Loving, the Board adopted the summary and approved the application for Asbestos Supervisor license for Johnathan Lee Northern and approved the application for Asbestos Worker for Raymond Maurice Richardson. The motion was unanimously approved by the following members: Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

David Dick presented to the Board a draft for the Boards approval Other Business on Fast Track Amendments Asbestos Contractor Responsibilities. The Board discussed the Amendments and upon motion by Mr. Cronan and seconded by Mr. Loving, the Board approve the Amendments. The motion was unanimously passed by the following members: Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

David Dick advised the board the Notice of Intended Regulatory Action (NOIRA) on Certified Home Inspectors Regulations has been approved by the Department of Planning and Budget and transmitted to the Secretary of Commerce

Mr. Loving moved that the Board delegate to its Executive Director and his staff the non-discretionary authority to grant a wavier of the 36-month refresher training requirement, found in Section 18VAC15-30-166 (A) (1) of the Board's Lead-Based Paint Activities Regulations, in compliance with Section 18VAC15-30-41, provided the refresher training was completed no later than 3 months after the expiration of the 36 months. Seconded by Mr. Cronan and the motion was approved by the following members: Heppner, Daniels, Varner, Loving, Dr. Sinyai, Hyatt and Cronan. Mr. Bouldin, Ms. Harlow and Ms. Hill were not present for the vote.

David Dick informed the Board that the RFP for Educational Programs is being developed by staff.

David Dick provided the Board with an update on the training program audit activity. The Board took no action.

David Dick reminded the Board members of the necessity to complete and turn in the Conflict of Interests Act/Ethics in Public Contracting forms no later than December 16, 2007.
