CLOSED MEETING: Ms. Buchwald moved that the Special Conference Committee of the Board of Nursing convene a closed meeting pursuant to Section 2.2-3711(A)(27) of the *Code of Virginia* at 9:04 A.M. for the purpose of deliberation to reach a decision in the matter of Ms. Wang. Additionally, Ms. Buchwald moved that Ms. Bargdill and Ms. Gray attend the closed meeting because their presence in the closed meeting is deemed necessary, and their presence will aid the Committee in its deliberations. The motion was seconded and carried unanimously.

RECONVENTION: The Committee reconvened in open session at 9:33 A.M.

Ms. Buchwald moved that the Special Conference Committee of the Board of Nursing certify that it heard, discussed or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and carried unanimously.

ACTION: Ms. Buchwald moved to offer Hongyan Wang a Consent Order for the Indefinite Suspension of her License and until such time as Ms. Wang can within 60 days of entry of the Order provide proof of completing Continuing Education requirements and assessed a Monetary Penalty of \$2,400 to be paid within 60 days entry of the Order. The basis of this decision will be set forth in a Consent Order which will be mailed to Hongyan Wang at her address of record with the Board. The motion was seconded and carried unanimously.

This Consent Order shall be effective upon endorsement of its findings, conclusions, and terms of consent by both Ms. Wang and the Board.

As provided by law, this decision shall become a Final Order thirty days after service of such order on Ms. Daniel unless a written request to the Board for a formal hearing on the allegations made against her is received from Ms. Daniel within such time. If service of the order is made by mail, three additional days shall be added to that period. Upon such timely request for a formal hearing, the Order shall be vacated.
