The first meeting of the Pharmacy and Therapeutic Committee will be to provide an overview of the Preferred Drug List (PDL) and prior authorization programs and to discuss organizational issues. The committee will not address any therapeutic drug classes at this meeting. There will be a public comment period for the second half of the meeting to hear comments on issues the Pharmacy and Therapeutic Committee should consider as it conducts its business.
