Whereas, an evaluation of the Commonwealth's documented funding need TO CONTINUE EXISTING TRANSIT SERVICES COMPARED TO projected revenues FROM EXISTING SOURCES has identified an average annual revenue gap of NO LESS THAN \$130 million over the next ten years, representing a drop of over 40% from existing funding levels, PRIOR TO ANY CONSIDERATION OF VIRGINIA'S SHARE OF ADDITIONAL CAPITAL FUNDING TO ADDRESS THE NEEDS OF WMATA OR THE UNCERTAINTY OF CONTINUED FEDERAL FUNDING;
