<u>Title: Transfer – Primary System of State Highways to Local System</u>

WHEREAS, the City Council of Lynchburg desires the transfer of Route F-906 and Route F-907 (Liberty Mountain Drive) in the City of Lynchburg from the Primary System of State Highways to the local system of roads, pursuant to §33.2-315, Code of Virginia 1950, as amended. The road segments' lengths total 0.92 of a mile and are located entirely within the corporate limits of the City of Lynchburg; and

WHEREAS, the City of Lynchburg receives road payments for the maintenance of its road system in accordance with §33.2-319, Code of Virginia 1950, as amended; and

WHEREAS, the City Council of Lynchburg provided the Commissioner of Highways with a resolution, attached hereto as Exhibit A, requesting the transfer of Route F-906 and Route F-907, as seen in the map attached hereto as Exhibit B; and

WHEREAS, pursuant to §33.2-315, *Code of Virginia* 1950, as amended, the Commonwealth Transportation Board may transfer a street from the Primary System of State Highways to the local system of roads of a locality that receives road payments under §33.2-319, Code of Virginia 1950, as amended;

NOW THERFORE, BE IT RESOLVED, that the road segments identified below, are hereby ordered transferred from the Primary System of State Highways to the local system of roads, pursuant to § 33.2-315, *Code of Virginia*, 1950, as amended.

CTB Decision Brief

Transfer of Routes F-906 and F-907
From VDOT Primary System to the Local System of Roads
Located in the City of Lynchburg

Issue: The City Council of Lynchburg has requested the Commonwealth Transportation Board (CTB) transfer the 0.34 mile length of Route F-906 and the 0.58 mile length of Route F-907 (Liberty Mountain Drive) in the City of Lynchburg from the Primary System of State Highways to the City of Lynchburg's local road system.

Facts: Routes F-906 and F-907 are located in the City of Lynchburg, which receives maintenance payments in accordance with § 33.2-319. The frontage road, located east of U.S. Route 29/460, now functions as a city street, not as a frontage road, and the City desires to continue to maintain the street.

The City of Lynchburg provided a resolution, dated March 8, 2022 (Exhibit A, attached), indicating the City of Lynchburg's request to transfer the total 0.92 mile length of Routes F-906 and F-907 (noted in blue on Exhibit B, attached) from the state's Primary system to the local system.

Upon review of the area, Virginia Department of Transportation (VDOT) staff determined the 0.92 mile road segments should be transferred from the Primary System of State Highways, pursuant to § 33.2-315 of the *Code of Virginia*, in accordance with the City of Lynchburg's request.

Recommendations: VDOT recommends the Commonwealth Transportation Board approve the transfer of the 0.92 mile length of Routes F-906 and F-907 as referenced above.

Action Required by CTB: The *Code of Virginia* requires a majority of the Board's members to approve the change proposed in this brief.

Result if Approved: If approved, VDOT will suspend all its maintenance activity on the roadway and the road will be transferred to the locality's system and become part of the Urban System.

Options: Approve or Deny

RESOLUTION: #R-22-020

RESOLUTION OF THE CITY OF LYNCHBURG, VIRGINIA

WHEREAS, the Lynchburg City Council requests that the Commonwealth Transportation Board transfer the frontage roads Route F-906 and Route F-907, known as Liberty Mountain Drive, from the Virginia Department of Transportation Primary System to the City of Lynchburg's local system of roads; and

WHEREAS, the roadways no longer functions as a frontage road; and

WHEREAS, the roadways are located within the City of Lynchburg corporate limits; and

WHEREAS, under Section 33.2-315 of the Code of Virginia (1950), as amended, a local governing body may request that the Commonwealth Transportation Board transfer such streets as it deems proper from the primary state highway system to the local system of roads operated by a locality receiving payments. Upon such transfer, the highways, bridges, and streets so transferred shall become for all purposes parts of the local system of roads operated by the City of Lynchburg.

NOW, THEREFORE BE IT RESOLVED, the City Council of Lynchburg, Virginia pursuant to Virginia Code Section 33.2-315, hereby requests that the Commonwealth Transportation Board authorize the transfer of those segments identified in the attached exhibit from the Primary system of the State Highways to the City of Lynchburg's local road system.

BE IT FURTHER RESOLVED, that the Lynchburg City Council requests that, for those segments identified on the attached exhibit, the Virginia Department of Transportation renumber the segments to be included as part of the local system; and,

BE IT FINALLY RESOLVED that a certified copy of this resolution be forwarded to the Appomattox Resident Administrator of the Virginia Department of Transportation.



WHEREAS, on October 4, 1956, the State Highway Commission, predecessor to the Commonwealth Transportation Board (CTB), designated the Interstate Highway System, including I-495, to be Limited Access Highways in accordance with then Article 3, Chapter 1, Title 33 of the 1950 *Code of Virginia*, as amended, and established the limited access line locations and limits as "the final locations of said routes, including all necessary grade separations, interchanges, ramps, etc."; and

WHEREAS, State Highway Project 0495-029-419, PE101 (UPC# 113414), extends the I-495 Express Lanes Northern Extension (NEXT) by approximately three (3) miles from Route 267 (Dulles Toll Road) Interchange to the George Washington Memorial Parkway in the vicinity of the American Legion Bridge to reduce congestion, improve safety and travel reliability, and provide additional travel choices. In addition, (i) a sidewalk will be provided along Route 694 (Lewinsville Road); (ii) a shared use path will be provided along Route 738 (Old Dominion Drive); (iii) a sidewalk and shared use path will be provided along Route 193 (Georgetown Pike); (iv) a sidewalk will be provided along Live Oak Drive; and (v) a shared use path will be provided along I-495 NB near the George Washington Memorial Parkway Interchange, all within the areas designated as limited access (the "Project"); and

WHEREAS, the expansion of I-495 requires modifications to the existing limited access lines as shown on the Limited Access Line Exhibits and the Limited Access Control Point Stations and Offsets Table (attached); and

WHEREAS, Virginia Department of Transportation (VDOT) held a Virtual Location and Design Public Hearing ("Hearing") for the Project, including the current and proposed locations of the limited access lines, on Monday, October 5, 2020, between 7:00 pm and 9:30 pm via Webex and allowed public input to be collected concerning the request: and

WHEREAS, VDOT held an In-Person (by appointment) Hearing for the Project, including the current and proposed locations of the limited access lines, on Thursday, October 8, 2020, between 4:00 pm and 8:00 pm at 1234 Ingleside Avenue, McLean, VA 22101, and allowed public input to be collected concerning the request; and

WHEREAS, proper notice of the Hearings were given in advance and posted on the Project website, and all citizens were given a full opportunity to express their opinions and recommendations for or against the Project as presented, their statements being duly recorded; and

WHEREAS, the economic, social and environmental effects of the Project have been duly examined and given proper consideration and this evidence, along with all other relevant evidence, has been carefully reviewed; and

WHEREAS, VDOT's Northern Virginia District Office has reviewed and approved the Interchange Justification Report Addendum on December 21, 2021, and found that it adequately addresses the impacts from the Project and the proposed LACCs; and

WHEREAS, the Project is in compliance with National Environmental Policy Act (NEPA) requirements and a Revised Environmental Assessment was prepared under an agreement between VDOT and the Federal Highway Administration (FHWA) and a Finding of No Significant Impact was approved on June 29, 2021; and

WHEREAS, the Project is located within a non-attainment area for ozone; and meets all applicable federal and state transportation conformity regulatory requirements as well as air quality guidance under NEPA. A Revised Air Quality Report Technical Report was completed by VDOT in coordination with FHWA in May 2021, and was approved by FHWA on June 29, 2021, finding that the Project will not cause or contribute to a new violation of the National Ambient Air Quality Standards established by the U.S. Environmental Protection Agency and thus will not have an adverse impact on air quality; and

WHEREAS, the Project is in Fairfax County and the County Board of Supervisors endorsed the proposed LACCs via resolution at their regular meeting on April 12, 2022 (attached); and

WHEREAS, the FHWA provided approval for State Highway Project 0495-029-419, P101 (UPC# 113414) and the proposed LACCs on April 11, 2022 (attached); and

WHEREAS, VDOT's Chief Engineer has determined that the proposed LACCs will not adversely affect the safety or operation of the highways; and

WHEREAS, VDOT has reviewed the requested LACCs and determined that all are in compliance with § 33.2-401 of the *Code of Virginia* and that the requirements of 24 VAC 30-401-20 have been met; and

WHEREAS, VDOT recommends approval of the LACCs as shown on the Limited Access Line Exhibits and the Limited Access Control Point Stations and Offsets Table (attached).

NOW, THEREFORE, BE IT RESOLVED, in accordance with § 33.2-401 of the *Code of Virginia* and 24 VAC 30-401-10 *et seq.*, that the CTB hereby finds and concurs in the determinations and recommendations of VDOT made herein, and directs that I-495 continue to be designated as a limited access control area, with the boundaries of limited access control being modified from the current locations as shown on the on the Limited Access Line Exhibits and the Limited Access Control Point Stations and Offsets Table (attached).

BE IT FURTHER RESOLVED, that the location of the sidewalks and shared use paths

within the area designated as limited access, and its construction and maintenance, is approved as proposed and presented at the Hearings, as the same may be modified during ongoing design review.

- **BE IT FURTHER RESOLVED**, that pedestrians are authorized to use the proposed sidewalks along Route 694 (Lewinsville Road), within the areas designated as limited access.
- **BE IT FURTHER RESOLVED**, that pedestrians and bicyclists are authorized to use the proposed shared use path along Route 738 (Old Dominion Drive), within the areas designated as limited access.
- **BE IT FURTHER RESOLVED**, that pedestrians and bicyclists are authorized to use the proposed sidewalk and shared use path along Route 193 (Georgetown Pike), within the areas designated as limited access.
- **BE IT FURTHER RESOLVED**, that pedestrians are authorized to use the proposed sidewalk along Live Oak Drive, within the areas designated as limited access.
- **BE IT FURTHER RESOLVED**, that pedestrians and bicyclists are authorized to use the proposed shared use path along northbound I-495 near the George Washington Memorial Parkway, within the areas designated as limited access.
- **BE IT FURTHER RESOLVED**, that the Commissioner of Highways is authorized to take all actions and execute any and all documents necessary to implement such changes.

Issues: The area designated as limited access previously approved for I-495 needs to be modified to accommodate the I-495 Express Lanes Northern Extension (NEXT) by approximately three (3) miles from Dulles Toll Road Interchange to the George Washington Memorial Parkway in the vicinity of the American Legion Bridge to reduce congestion, improve safety and travel reliability, and provide additional travel choices. This will require that the existing limited access lines previously approved along I-495 be adjusted to accommodate the project. These changes require the approval of the Commonwealth Transportation Board (CTB) pursuant to § 33.2-401 of the *Code of Virginia*, and 24 VAC 30-401-10 *et seq*.

Facts:

- Limited access control for I-495 was previously established on October 4, 1956 by the State Highway Commission, predecessor to the CTB, designated the Interstate Highway System, including I-495, to be Limited Access Highways in accordance with then Article 3, Chapter 1, Title 33 of the 1950 *Code of Virginia*, as amended, and established the limited access line locations and limits as "the final locations of said routes, including all necessary grade separations, interchanges, ramps, etc.".
- State Highway Project 0495-029-419, PE101 (UPC# 113414) provides for the extension of the I-495 Express Lanes Northern Extension (NEXT) by approximately three (3) miles from Route 267 (Dulles Toll Road) Interchange to George Washington Memorial Parkway in the vicinity of the American Legion Bridge to reduce congestion, improve safety and travel reliability, and provide additional travel choices. In addition, (i) a sidewalk will be provided along Route 694 (Lewinsville Road); (ii) a shared use path will be provided along Route 738 (Old Dominion Drive); (iii) a sidewalk and shared use path will be provided along Route 193 (Georgetown Pike); (iv) a sidewalk will be provided along Live Oak Drive; and (v) a shared use path will be provided along I-495 NB near the George Washington Memorial Parkway Interchange, all within the areas designated as limited access. These improvements will impact the existing limited access control lines, as shown on the Limited Access Line Exhibits and the Limited Access Control Point Stations and Offsets Table (attached).
- The Virginia Department of Transportation (VDOT) held a Virtual Location and Design Public Hearing ("Hearing") for the Project, including the current and proposed locations of the limited access lines, on Monday, October 5, 2020, between 7:00 pm and 9:30 pm via Webex and allowed public input to be collected concerning the request.
- VDOT held an In-Person (by appointment) Hearing for the Project, including the current and proposed locations of the limited access lines, on Thursday, October 8,

- Proper notice of the Hearings were given in advance and posted on the Project website, and all citizens were given a full opportunity to express their opinions and recommendations for or against the Project as presented, their statements being duly recorded.
- The economic, social, and environmental effects of the Project have been duly examined and given proper consideration and this evidence, along with all other relevant evidence, has been carefully reviewed.
- VDOT's Northern District Office has reviewed and approved the Interchange Justification Report Addendum on December 21, 2021, and found that it adequately addresses the impacts from the Project and the proposed LACCs.
- The Project is in compliance with National Environmental Policy Act (NEPA) requirements and a revised Environmental Assessment was prepared under an agreement between VDOT and the Federal Highway Administration (FHWA) and a Finding of No Significant Impact was approved on June 29, 2021.
- The Project is located within a non-attainment area for ozone; and meets all applicable federal and state transportation conformity regulatory requirements as well as air quality guidance under NEPA. - FHWA has provided the approval for State Highway Project 0495-029-419, P101, (UPC# 113414) and the proposed LACCs on April 11, 2022 (attached).
- VDOT's Chief Engineer has determined that the proposed LACCs will not adversely affect the safety or operation of the highways.
- The proposed LACCs are in compliance with § 33.2-401 of the *Code of Virginia* and with the policies and requirements of the CTB contained in 24 VAC 30-401-10 *et seq*.

Recommendations: It is recommended, pursuant to § 33.2-401 of the *Code of Virginia*, and 24 VAC 30-401-10 *et seq.*, that I-495 continue to be designated as a Limited Access Highway with the LACCs modified and/or established as shown on the attached exhibits. This action will modify the limited access line and right of way previously approved by the CTB's predecessor, the State Highway Commission, on October 4, 1956.

Action Required by CTB: The *Code of Virginia* § 33.2-401 and 24 VAC 30-401-10 *et seq.* require a majority vote of the CTB to approve the recommended LACCs. The CTB will be presented with a resolution for a formal vote to approve the LACCs for the Project and to provide the Commissioner of Highways the requisite authority to execute all documents necessary to implement the LACCs.

Result, if Approved: The Commissioner of Highways will be authorized to execute any and all documents needed to comply with the resolution, and the I-495 Express Lanes Northern Extension (NEXT) Project will move forward.

Options: Approve, Deny, or Defer.

Virtual Hearing Comments/Reactions: There were a minimum of 180 citizens that participated in the Virtual Hearing, exact numbers are unknown due to some individuals joining multiple times and other connections that had multiple people present. There were twelve (12) telephone participants, twenty-four (24) citizens watching from VDOT's YouTube Live channel. Additionally, there were seventy-nine (79) views of the meeting recording on the 495 NEXT project website and/or VDOT's YouTube Live channel through March 24, 2021. There were twenty-nine (29) citizen comments during the virtual public hearing.

In-Person Hearing Comments/Reactions: There were twenty-five (25) citizens who attended the In-Person Hearing. There were four (4) comments submitted at the in-person public hearing, eight (8) comments provided by the court reporter, and 720 comments sent by mail, email and online that were received. There were a total of 761 comments received during the comment period as a result of both Hearings.

As you may be aware, The Virginia Department of Transportation (VDOT) is developing plans for the referenced State Highway Project, the scope of work involves extending the I-495 Express Lanes Northern Extension (NEXT) by approximately three miles from Route 267 (Dulles Toll Road) Interchange to the George Washington Memorial Parkway in the vicinity of the American Legion Bridge to reduce congestion, improve safety and travel reliability, and provide additional travel choices.

A sidewalk will be provided along Route 694 (Lewinsville Road), a shared use path will be provided along Route 738 (Old Dominion Drive), a sidewalk and shared use path will be provided along Route 193 (Georgetown Pike), a sidewalk will be provided along Live Oak Drive; and a shared use path will be provided along I-495 NB near the George Washington Memorial Parkway Interchange within the areas designated as limited access.

As a result of the design of the Project, the Limited Access Lines need to be modified.

I-495 was designated as a Limited Access Highway by the State Highway Commission, predecessor to the Commonwealth Transportation Board, on October 4, 1956. This Project is in compliance with National Environmental Policy Act requirements and a Revised Environmental Assessment was prepared under an agreement between VDOT and the Federal Highway Administration and a Finding of No Significant Impact was approved on June 29, 2021.

Therefore, VDOT is requesting your concurrence in modifications to the existing limited access lines along I-495 as shown on Limited Access Line Exhibits and the Limited Access Control Point Stations and Offsets Table (attached).

Moved by Mr. Flythe, seconded by Senator Helson, that, it so be declared that, Whereas, by action of the Congress of the United States, whereby all routes on the National System of Interstate and Defense Highways are to be constructed to interstate standards and whereas, one of the requirements of interstate standards is the control of access to these routes; Therefore, be it resolved that all routes on the National System of Interstate and Defense Highways within the confines of the Commonwealth of Virginia, upon determining the final location of said routes, including all necessary grade separations, interchanges, ramps, atc., are here and now designated Limited Access Highways, pursuant to Article 5, Chapter 1, Title 35, of the Code of Virginia of 1950, as amended, Notion parried.

On motion made by Senator Melson, seconded by Mr. Sarrow, the Chairman was instructed to report to the Burean of Public Roads, at a secting called for October 9, that the Virginia Department of Highways will undertake one-third of the cost of operation and maintenance of the proposed bridge over the Potouse River at Jones Point, with the thought that the other two-thirds shall be borne by the State of Maryland and the District of Columbia. This could be handled by written agreement looking to appropriate Pederal Legislation.

CTB Decision Brief

Revised FY2022-2027 Six-Year Improvement Program Transfers For March 19, 2022 through April 20, 2022

Issue: Each year the Commonwealth Transportation Board (CTB) must adopt a Six-Year Improvement Program (Program) in accordance with statutes and federal regulations. Throughout the year, it may become necessary to transfer funds between projects to have allocations available to continue and/or initiate projects and programs adopted in the Program.

Facts: On January 12, 2022, the CTB granted authority to the Commissioner of Highways (Commissioner), or his designee, to make transfers of allocations programmed to projects in the Revised Six-Year Improvement Program of projects and programs for Fiscal Years 2022 through 2027 to release funds no longer needed for the delivery of the projects and to provide additional allocations to support the delivery of eligible projects in the Revised Six-Year Improvement Program of projects and programs for Fiscal Years 2022 through 2027 consistent with Commonwealth Transportation Board priorities for programming funds, federal/state eligibility requirements, and according to the following thresholds based on the recipient project:

In addition, the CTB resolved that the Commissioner should bring requests for transfers of allocations exceeding the established thresholds to the CTB on a monthly basis for its approval prior to taking any action to record or award such action.

The CTB will be presented with a resolution for formal vote to approve the transfer of funds exceeding the established thresholds. The list of transfers from March 19, 2022 through April 20, 2022 is attached.

Recommendations: VDOT recommends the approval of the transfers exceeding the established thresholds from donor projects to projects that meet the CTB's statutory requirements and policy goals.

Action Required by CTB: The CTB will be presented with a resolution for a formal vote to adopt changes to the Revised Program for Fiscal Years 2022–2027 that include transfers of allocated funds exceeding the established thresholds from donor projects to projects that meet the CTB's statutory requirements and policy goals.

Result, if Approved: If approved, the funds will be transferred from the donor projects to projects that meet the CTB's statutory requirements and policy goals.

Options: Approve, Deny, or Defer.

WHEREAS, the Board adopted a Revised Fiscal Years 2022-2027 Program on January 12, 2022; and

WHEREAS, the Board is required by §§ 33.2-214(B) and 33.2-221(C) of the *Code of Virginia* to administer and allocate funds in the Commonwealth Transportation Fund and the Transportation Trust Fund, respectively; and

WHEREAS, § 33.2-214(B) of the *Code of Virginia* provides that the Board is to coordinate the planning for financing of transportation needs, including needs for highways, railways, seaports, airports, and public transportation and is to allocate funds for these needs pursuant to §§ 33.2-358 and Chapter 15 of Title 33.2 (33.2-1500 et seq.) of the *Code of Virginia*, by adopting a Program; and

WHEREAS, §§ 33.2-1526 and 33.2-1526.1 authorize allocations to local governing bodies, transportation district commissions, or public service corporations for, among other things, capital project costs for public transportation and ridesharing equipment, facilities, and associated costs; and

WHEREAS, the projects shown in Appendix A were not included in the Revised FY 2022-2027 Program adopted by the Board on January 12, 2022; and

WHEREAS, the Board recognizes that the projects are appropriate for the efficient movement of people and freight and, therefore, for the common good of the Commonwealth.

CTB Decision Brief

Addition of Projects to the Revised Six-Year Improvement Program for Fiscal Years 2022 – 2027

Issue: Each year the Commonwealth Transportation Board (CTB) must adopt a Six-Year Improvement Program (Program) and allocations in accordance with the statutory formula.

Facts: The CTB must adopt a Program of anticipated projects and programs by July 1st of each year in accordance with § 33.2-214(B) of the *Code of Virginia*. On June 23, 2021, after due consideration, the CTB adopted a Final FY 2022-2027 Program. On January 12, 2022, the CTB adopted a Revised FY 2022-2027 Program.

Recommendations: The Virginia Department of Transportation (VDOT) recommends the addition of the projects in Appendix A to the Revised Program for FY 2022–2027.

Action Required by CTB: The CTB will be presented with a resolution for a formal vote to add the projects listed in Appendix A to the Revised Program for FY 2022–2027 to meet the CTB's statutory requirements.

Result, if Approved: If the resolution is approved, the projects listed in Appendix A will be added to the Revised Program for FY 2022-2027.

Options: Approve, Deny, or Defer.

WHEREAS, Interstate 81 at Exit 300 Southbound Acceleration Lane Extension UPC 111054 Project (the Project) was previously submitted for consideration and selected for \$3.4 million in funding through the High Priority Projects Program in the second round of the prioritization process pursuant to section 33.2-214.1; and

WHEREAS, the Project was ranked 9 out of 19 projects selected in Round 2 in the Staunton District with a score of 11.1; and

WHEREAS, on June 17, 2020, the Board approved a SMART SCALE budget increase for the Project of up to \$5.1 million using surplus High Priority Project funds; and

WHEREAS, based on the budget increase, the Project was re-scored resulting in a revised score of 4.5 and a decrease in prioritization by seven projects; and

WHEREAS, the Virginia Department of Transportation (VDOT) received bids for the Project on April 27, 2022 and determined that the price proposals were responsive and represented good competition; and

WHEREAS, based on the price proposals received, the current estimated cost for award of the Project exceeds the current budget of \$8.5 million (which takes into consideration the prior SMART SCALE increase approved by the Board) by \$750,741; and

WHEREAS, the Virginia Department of Transportation (VDOT) has reviewed the Project's scope to identify opportunities to remain within the current budget while maintaining

substantially the same project benefits and has determined that reducing the Project's scope in order to remain within the current budget would render the Project incapable of achieving substantially the same benefits as the original scope; and

WHEREAS, VDOT recommends Board approval of a second SMART SCALE budget increase for the Project in the amount of up to \$750,741 and use of surplus High Priority Projects Program funds (UPC -21770) to fund the increase; and

WHEREAS, this second SMART SCALE budget increase will increase the total SMART SCALE budget to date for the Project from the original amount at project selection of \$3.4 million to approximately \$9.3 million; and

WHEREAS, taking into consideration the proposed SMART SCALE budget increase, the Project was re-scored resulting in a revised score of 4.1 with no change in prioritization rank; and

WHEREAS, the Project has thus far incurred expenditures totaling \$917,274.

NOW THEREFORE BE IT RESOLVED, by the Commonwealth Transportation Board, that the second SMART SCALE budget increase in the amount of up to \$750,741 for the Project is necessary to award and fund the Project and is therefore approved; and

THEREFORE BE IT FURTHER RESOLVED, by the Commonwealth Transportation Board, that is the Board's intent and VDOT is directed to allocate surplus High Priority Project funds (UPC -21770) to fund the budget increase.

CTB Decision Brief SMART SCALE Project Budget Increase for Interstate 81 at Exit 300 Southbound Acceleration Lane Extension Project UPC 111054 in Warren County

Issue: Interstate 81 at Exit 300 Southbound Acceleration Lane Extension Project (UPC 111054) (the Project) was previously selected for funding under the Commonwealth Transportation Board's (Board) SMART SCALE Prioritization Policy/Process. In June 2020, the Board approved a \$5.1 million budget increase based on a revised Project scope. The Virginia Department of Transportation (VDOT) received bids for the Project on April 27, 2022 and determined that the price proposals were responsive and represented good competition, however, based on the price proposals, the cost to award the Project exceeds the approved budget by \$750,741. VDOT recommends Board approval of a second SMART SCALE budget increase for this Project in the amount of up to \$750,741 and use of surplus High Priority Project funds from UPC -21770 to fund the increase. Board approval of the budget increase is required.

Facts: Item 12 of the Board's SMART SCALE Prioritization Policy/Process, adopted December 8, 2021, provides that a project that has been selected for funding must be re-scored and the funding decision reevaluated if there are significant changes to either the scope or cost of the project, such that the anticipated benefits relative to funding requested would have substantially changed.

Item 12.a. of the Board's SMART SCALE Prioritization Process provides that if an estimate increases prior to project advertisement or contract award that exceeds the following thresholds, and the applicant is not covering the increased cost with other funds, Board action is required to approve the budget increase:

- i. Total Cost Estimate <\$5 million: 20% increase in funding requested
- ii. Total Cost Estimate \$5 million to \$10 million: \$1 million or greater increase in funding requested
- iii. Total Cost Estimate > \$10 million: 10% increase in funding requested; \$5 million maximum increase in funding requested

The Interstate 81 at Exit 300 Southbound Acceleration Lane Extension Project (UPC 111054) was previously submitted for consideration and selected for \$3.4 million in funding through the High Priority Projects Program. The Project was ranked 9 out of 19 projects selected for funding in SMART SCALE Round 2 in the Staunton District with a score of 11.1.

On June 17, 2020, based on a revised Project scope, the Board approved a budget increase of up to \$5.1 million for the Project using surplus High Priority Projects Program funds so the Project could continue to advance. At that time, the Project was rescored, resulting in a revised score of 4.5 and a reduced prioritization by 7 projects.

VDOT received bids for the Project on April 27, 2022 and determined that the price proposals were responsive and represented good competition.

However, based on the price proposals, the cost to award the Project exceeds the current budget of \$8.5 million (which takes into consideration the increase from June 2020) by approximately \$750,741.

VDOT has reviewed the Project's scope to identify opportunities to remain within the original budget while maintaining substantially the same project benefits and has determined that reducing the Project's scope in order to remain within the current budget would render the Project incapable of achieving substantially the same benefits. The Project was rescored based on the increased budget, resulting in a score of 4.1, with no change in prioritization.

Thus far, the Project has incurred expenditures of \$917,274.

Based on the foregoing, VDOT recommends Board approval of a second SMART SCALE budget increase for the Project in an amount of up to \$750,741 using surplus High Priority Projects Program funds (UPC -21770) to fund the budget increase.

This second SMART SCALE budget increase will increase the total SMART SCALE budget to date for the Project from \$3.4 million at project selection to approximately \$9.3 million.

Recommendation: VDOT recommends that the Board approve a second SMART SCALE budget increase in the amount of up to \$750,741 for the Project using surplus High Priority Projects Program funds (UPC -21770) to fund the budget increase.

Action Required by CTB: The CTB will be presented with a resolution for a formal vote to approve the SMART SCALE budget increase for the Interstate 81 at Exit 300 Southbound Acceleration Lane Extension Project (UPC 111054) and to provide for the Board's intent and direction to fund the increase with surplus High Priority Projects Program funds.

Result, if Approved: If approved, funds will be transferred so that the Project can be awarded.

Options: Approve, Deny, or Defer.

The purpose of this project is pave a 6.2-mile segment of roadway connecting Route 460 Connector Phase I at Station 89+00.00 with Route 121-Corridor Q Intersection at Station 415+76.25. The Route 460 Connector Phase II Finish Grade project follows the previously completed Rough Grade construction (UPC 100707). The rough-grade roadbed was constructed to accommodate four lanes, but the typical section for paving has been reduced to two lanes with climbing lanes where necessary. The project includes an at-grade intersection with Route 609 at Bull Gap. The paving project will consist of the placement of aggregate subbase and asphalt, as well as installation of final drainage structures, guardrail, striping, and signage, and permanent seeding. Surface drainage pipes will be installed or replaced and fore bays will be added to existing basins to complete the permanent drainage configuration. Temporary activities will include installation of erosion and sediment control structures to include temporary sediment basins, sediment traps, silt fence, and temporary seeding. The paving project will occur entirely within existing VDOT right-of-way. Construction will be contained within previous disturbance associated with the rough-grade roadway template, and no additional right-of-way will be acquired. Subsequently, NEPA updates were completed as work packages were released for rough-grade roadbed construction. All paving activity falls within the previously evaluated NEPA boundaries. As such, no new significant impacts will be incurred as a result of the paving project. This project is within existing Limited Access, no new right-of-way or utility relocations will be required. The purpose of this project is to improve ramp geometry to allow vehicles to reach higher speeds on the on-ramp B thus causing improved merging onto SB I-95/EB I-64. Included in this project is the removal of the Brook Road "slip ramp" from westbound Leigh Street. The project limits extend from the intersection of Belvidere Street and Leigh Street (but not including any work at this intersection) to the merge onto SB I-95/EB I-64.

The majority of the projects will fit within the existing limited access right-of-way, along with temporary construction easements from two parcels.
