Minutes of the meeting of the Milk Commission, held at the Virginia Department of Forestry, 900 Natural Resources Drive, training room; Charlottesville, VA 22903.

THE COMMISSION:

Kenneth Smith called the meeting to order at 10:35 a.m. Kenneth Smith asked for a motion to accept the minutes from the previous meeting. Robb Watters so moved and Patrick Crawford seconded the motion. The minutes were accepted as written.
