Ms. Henshaw gave an update on the current status of the regulatory review process for the Condominium Regulations. The Notice of Regulatory Review Intended Regulatory Action (NOIRA) has been published and the 30- **Process** day public comment period ended on July 6, 2011.

Update on

The Board adopted a legislative proposal at the June 9, 2011, meeting that would provide for administrative termination of condominium and time-share registrations in the event that certain criteria has been met. The proposal is intended to address time-share and condominium registrations that have had no activity and all attempts to contact the declarant have been unsuccessful. The Committee members agreed by consensus with the rationale and criteria for this proposal and discussed various options related to administrative terminations.

Ms. Henshaw provided the Committee with a draft of the Condominium Review Draft CIC Regulations that incorporates the suggested changes from the last Condominium Committee meeting pertaining to the public offering statement Regulations requirements. The Committee discussed the suggested revisions and updated section-by-section changes to the draft text.
