Case No.: 223018** Jay M. Bukzin appeared with counsel, Leonard W. Dooren, to discuss the allegations set forth in the Notice of the Board dated June 10, 2024. Michael D. Sock, D.M.D., M.D., appeared on behalf of Dr. Bukzin. The Committee received additional information and statements from Dr. Bukzin, Dr. Sock and Mr. Dooren and discussed the allegations with them.
- Closed Meeting:** Dr. Dawson moved that the Committee convene a closed meeting pursuant to § 2.2-3711(A)(27) of the Code of Virginia for the purpose of deliberation to reach a decision in the matter of Jay Bukzin. Additionally, Dr. Dawson moved that Ms. Weaver and Ms. Lee attend the closed meeting because their presence in the closed meeting was deemed necessary and their presence would aid the Committee in its deliberations. The motion was seconded and passed.
- Reconvene:** Dr. Dawson moved that the Committee certify that it heard, discussed, or considered only public business matters lawfully exempted from open meeting requirements under the Virginia Freedom of Information Act and only such public business matters as were identified in the motion by which the closed meeting was convened. The motion was seconded and passed.

The sanctions reported by Ms. Weaver were that Dr. Bukzin was assessed a \$2,000.00 monetary penalty; and that within 6 months from the date of entry of the Order, he shall successfully complete a 3 hour continuing education course in the subject of pre-operative evaluation and surgical planning; and a 3 hour continuing education course in the subject of risk management.

It was further ordered that within 30 days from the date of entry of the Order, Dr. Bukzin shall provide a written statement to the Board certifying that he has read and shall comply with 18VAC60-21-100 of the Regulations Governing the Practice of Dentistry.

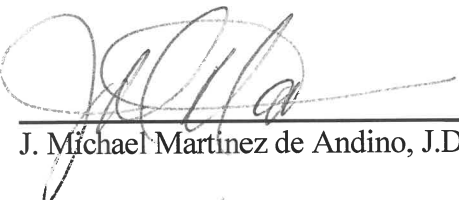
Dr. Dawson moved to adopt the decision of the Committee. The motion was seconded and passed.
