Meeting at 600 East Main Street, Richmond VA was called to order at 10:05 AM by Mrs. Eleanor Brown, chair.

APPROVAL OF THE ORDER OF BUSINESS

Motion made by Ms. Ridder to approve the order of business noting that some flexibility will be needed to accommodate guest's arrival; motion seconded by Mr. Thompson and passed unanimously.

The Honorable Matthew Strickler, Secretary of Natural Resources made a few remarks about land conservation in Virginia.

CHAIR'S REPORT/COMMENTS

To facilitate making grants from the Special Forestry Fund in 2018 calendar year, a Board of Trustees meeting has been added in early December.

EXECUTIVE DIRECTOR'S REPORT

Our baseline budget has been restored and Brett thanked everyone for helping. The Land Preservation Tax Credit is higher than budgeted. VOF recently recorded its first easements in the cities of Richmond and Alexandria.

FY19 BUDGET

Anna Chisholm led trustees through the proposed FY19 budget. Motion made by Mr. Slater to approve budget as presented; motion seconded by Ms. Ridder and passed unanimously. (ATTACHMENT B)

RESOLUTION

VIRGINIA OUTDOORS FOUNDATION

BOARD OF TRUSTEES RESOLUTION TO CONVEY THE SMITH FARM TO PULASKI COUNTY

WHEREAS, Margaret V. Smith bequeathed real property containing 94+/- acres fronting on the New River in Pulaski County, Virginia to VOF in March 2016, with the understanding that VOF would preserve the land as farmland or would work with a local government or other organization to facilitate development of the property into a public park.

WHEREAS, Pulaski County recently purchased several tracts of land just upriver from and adjacent to the Smith Farm with plans to expand recreational opportunities in the area and has expressed interest in developing the Smith Farm into a public park.

WHEREAS, VOF and Pulaski County have formally discussed the future of the Smith Farm. Though some details remain to be worked out, the County has officially confirmed its interest in the property and understands that the conveyance shall be subject to certain restrictions and conditions generally outlined below:

- 1) The Smith Farm shall be conveyed to Pulaski County as a gift. However, the County shall pay VOF \$48,950 to cover administrative costs and other costs incurred in holding and facilitating the property's transfer.
- 2) The County shall donate to VOF an open-space easement on the majority of the 94- acre farm plus two adjacent EDA-owned parcels (14.5 acres by property description) with terms agreeable to VOF.
- 3) The majority of the property shall be maintained and used as a recreational park or in agricultural use or a combination thereof.
- 4) A portion of the property (7+/- acres) fronting on Dudley's Ferry Road shall be excluded from the easement. Funds received from the sale or development of this tract shall be used exclusively for the development of the future park.
- 5) Pulaski County shall honor the life estate of John Housel and lease with (farmer) Darryl Woodyard.
- 6) Pulaski County shall include VOF in future discussions and all public meetings regarding the property's planning and development and shall publicize VOF's substantial role in facilitating its transfer.
- 7) The future park shall have at least one sign installed that informs the public that the park was made possible by a generous gift from Margaret V. Smith and VOF, and include the VOF logo.

RESOLVED by the Virginia Outdoors Foundation Board of Trustees on this day the 21st of June, 2018 that VOF hereby agrees to transfer the Smith Farm to Pulaski County following the outline of terms described above.

WHEREAS, the Virginia Outdoors Foundation (VOF) is an instrumentality of the Commonwealth of Virginia subject to the Security of Public Funds (Code of Virginia §2.2-4400) and the Investment of Public Funds Acts (Code of Virginia §2.2-4500); and

WHEREAS, an Investment Policy will guide VOF to obtain the highest possible yield on designated reserve fund assets; consistent with constraints imposed by its safety objectives, cash flow considerations, and Virginia state laws that restrict the placement of public funds; and

WHEREAS, the Investment Policy establishes guidelines for the safeguarding and efficient management of VOF funds and shall apply to all activities with regard to the investment of funds; and

WHEREAS, the Executive Director, in consultation with other members of the VOF Management Team and the Finance, Audit and Compliance Committee, recommends the adoption of the Proposed Investment Policy; now, therefore, be it

RESOLVED by the Virginia Outdoors Foundation Board of Trustees this 21st day of June 2018, That the proposed Investment Policy is hereby, adopted as attached.
