Additionally, he moved that Dr. Harp and Ms. Wood attend the closed meeting because their presence in the closed meeting was deemed necessary and would aid the Committee in its deliberations.

**RECONVENE:** Having certified that the matters discussed in the preceding closed session met the requirements of §2.2-3712 of the Code, the Committee re-convened in open session and announced its decision.

**DECISION:**

Upon a motion by Dr. Taminger, and duly seconded by Dr. Archer, the Committee voted to refer this matter to a formal hearing since the suspension or revocation of Dr. Anglero's license may be justified which is not within the authority of the Committee pursuant to §54.1-2400(10) of the Code of Virginia.

**ADJOURNMENT:**


The Committee adjourned at 11:23 a.m.
