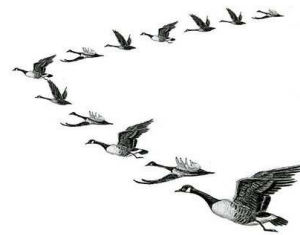

### **Chairman's Business**

Also, they are planning to start work on the finished water transmission line that will cross the Goose Creek Reservoir through a tunnel. The Loudoun Water representatives explained the plans, the progress made to date, and the upcoming schedule.
