VIRGINIA REAL ESTATE BOARD EDUCATION COMMITTEE MEETING REPORT

The Real Estate Board Education Committee met on Wednesday, November 13, 2019, at 2:00 p.m., at the Department of Professional & Occupational Regulation in Richmond, Virginia.

Ms. Grimsley called the meeting to order at 2:14 p.m.

A motion was made to approve the agenda. The Committee approved it unanimously.

Education providers should upload a candidate picture to PSI whenever possible.

Board staff was in contact with PSI regarding the questions about where responsibility lies for uploading candidate pictures. An education provider should upload a candidate picture whenever transmitting data to PSI. If an education provider does not transmit course completion information to PSI for a candidate, such provider should advise the candidate either (1) that the candidate will need to be sure that another education provider uploads a picture or (2) to contact the Board. Any questions may be directed to Board staff.

Education providers do not need to keep candidate pictures with student records.

The Committee approved suggestions from Board staff to make edits to applications.

Board staff suggested that Question 11 be removed from the Continuing Education/Post-License Course Approval Application. The Committee directed staff to edit the question so as to give a direction ("provide an Instructor Resume Worksheet for each instructor for whom approval to teach the course is sought").

Board staff also suggested that the Instructor Resume Worksheet be edited so that III.3 and 4 no longer require supporting documentation for certifications and designations and that III.2 and 4 be restricted to five years to match III.1. The Committee approved these changes.

Further, Board staff requested permission to eliminate Questions 9, 10, and 11 from the Pre-License Education Instructor application, as the information in these questions is already provided in the Instructor Resume Worksheet. The Board approved these changes.

Board staff asked the Committee whether the NAR Code of Ethics should be provided in every course where referenced as course material. The Committee stated that no general rule could be formed given the variety of uses of the NAR Code of Ethics in education courses.

<u>The Committee approved revisions to Continuing Education/Post-License Course Approval Application.</u>

The Committee approved changes to the Continuing Education/Post-License Course Approval Application in order to account for courses that have already been approved by the Board. Such courses will now provide a timed course outline and any material that has changed since the last approval. Board staff estimates that this change could cut the size of the Committee file by about thirty percent.

The Committee recommended approving a licensee's request for a Continuing Education waiver.
