The Virginia Marine Resources Commission (VMRC) proposes to amend Chapter 4VAC20-1350-10 et seq., "Pertaining to General Oyster Planting Ground Lease Renewal Fee", to allow for online applications and payments.

The purpose of amending this regulation is to increase regulatory efficiency by allowing for online applications and payments.

### Mandate and Impetus

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including marine shellfish regulations.

[Impetus] Current regulations do not allow for online renewal applications. This would increase the available resources to industry to be able to apply for and pay fees.
