The promulgating agency is the Real Estate Appraiser Board ("the Board"). Section 54.1-2013 of the Code of Virginia gives the Board the power and duty to establish regulations.

Code of Virginia § 54.1-201(A)(1) gives the Board the power and duty to “establish the qualifications of applicants for certification or licensure by any such board, provided that all qualifications shall be necessary to ensure either competence or integrity to engage in such profession or occupation.”

Code of Virginia § 54.1-201(A)(5) gives authority to the Board to promulgate regulations. It states, in part, that the Board has the power and duty “[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) necessary to assure continued competency, to prevent deceptive or misleading practices by practitioners and to effectively administer the regulatory system administered by the regulatory board.”

The regulation enables the Board to fulfill the statutory requirements established in Chapter 20.1 of Title 54.1 of the Code of Virginia. Further, the regulation is necessary to ensure that the Board’s statutory requirements are executed in the least burdensome and most efficient and cost-effective manner possible while protecting the health, safety, and welfare of the citizens of Virginia.

**Effectiveness**

The regulation meets the criteria set forth in the Office of Regulatory Management procedures. The regulation contains the requirements for obtaining a (i) license as an appraiser or appraiser trainee; (ii) certification as an instructor; and (iii) registration of business entities, renewal and reinstatement of licenses, certifications, and registrations, standards of professional conduct to ensure competence and integrity of all regulants and to administer the regulatory program in accordance with Chapters 20.1 of Title 54.1 of the Code of Virginia. The regulation is necessary for the protection of public health, safety, and welfare and is clearly written and understandable.

On October 17, 2023, the Board voted to retain the regulation “as is” without any change, as explained further in the “Small Business Impact” section. In accordance with the Governor’s Executive Directive Number One (2022), the Board is currently undertaking a separate action to perform a comprehensive line-by-line review of this regulation.

Code of Virginia §§ 54.1-201(A)(1), 54.1-201(A)(5), and 54.1-2013 mandate the Board promulgate regulations. The continued need for the regulation is established in statute. Repeal of the regulation would remove the current public protections provided by the regulation. The Board provides protection to the safety and welfare of the citizens of the Commonwealth by ensuring that only those individuals or firms that meet specific criteria set forth in the statutes and regulations are eligible to receive a real estate appraiser license, instructor certification, and business registration. The Board is also tasked with ensuring that its regulants meet standards of practice that are set forth in the regulations.

There were no comments or complaints received during the public comment period. The Real Estate Appraiser Board Rules and Regulations are clearly written, easily understandable, and do not overlap, duplicate or conflict with federal or state law or regulation.

The most recent periodic review of the regulation occurred in 2019. Currently, the Board is conducting a comprehensive review of the regulation.
