MINUTE 3 - Final Regulation: Virginia Water Protection Permit Program Regulation and VWP General Permits (9VAC25-210, 9VAC25-660, 9VAC25-670, 9VAC25-680, and 9VAC25-690) - 2021 Legislation Amendment

Melanie Davenport, Division of Water Permitting, presented a final exempt regulatory amendment to 9VAC25-210, 9VAC25-660, 9VAC25-670, 9VAC25-680, and 9VAC25-690. Ms. Davenport informed the Board that the amendments were necessary in order to incorporate changes to the State Water Control Law made during the 2021 General Assembly session regarding compensatory mitigation bank service areas and proximity to the impact site. Ms. Davenport provided a synopsis of the changes made by Chapter 265 by the 2021 Acts of Assembly. Chapter 265 revised compensation plans to include the information now required by § 62.1-44.15:23. It also clarifies language regarding the purchase of mitigation bank credits and in-lieu fee program credits with a primary service area and the analysis for justification of permittee-responsible compensation. Ms. Davenport then went through the regulatory amendments incorporating the necessary changes and the final exempt process.

MINUTE NO. 5 Amendments to 9VAC25-900 (Certification of Nonpoint Source Nutrient Credits) to Implement House Bill 1982 - Final Exempt

Allan Brockenbrough of the Office of VPDES Permits presented to the Board a final exempt amendment to 9VAC25-900 (Certification of Nonpoint Source Nutrient Credits) to implement modifications to the Code of Virginia adopted in Special Session 1 of the 2021 General Assembly. The amendment allows facilities that are issued an individual VPDES permit regulating stormwater discharges that requires nitrogen and phosphorus monitoring at the facility to acquire, use and transfer credits for compliance with any waste load allocations. This provision was previously only available to facilities registered under the Industrial Stormwater General Permit (9VAC25-151).

Board Decision

Based on the briefing material and the staff presentation, the Board voted unanimously to (1) adopt the amendment to Certification of Nonpoint Source Nutrient Credits (9VAC25-900) as amended and presented, and (2) affirm that it will receive, consider and respond to petitions by any person at any time with respect to reconsideration or revision of the regulation, as provided by the Administrative Process Act.

MINUTE NO. 6 Amendments to 9VAC25-720 (Water Quality Management Planning Regulation) to Implement House Bill 2129 and Senate Bill 1354 - Final Exempt

Allan Brockenbrough of the Office of VPDES Permits presented to the Board final exempt amendments to 9VAC25-720 (Water Quality Management Planning Regulation) to implement modifications to the Code of Virginia adopted in Special Session 1 of the 2021 General Assembly. These amendments implement reduced Total Nitrogen and/or Total Phosphorus waste load allocations for seven municipal wastewater treatment facilities and the transfer of two waste load allocations as outlined in the Enhanced Nutrient Removal Certainty (ENRC) Program included in the legislation.

MINUTE 8 — Chesapeake Bay Preservation Area Designation and Management Regulations - 9VAC25-830 — Final Amendment - Coastal Resilience and Adaptation to Sealevel Rise and Climate Change Criteria

Justin Williams, Office of Watershed and Local Government Assistance Programs, presented final amendments to the Chesapeake Bay Preservation Area (CBPA) Designation and Management Regulations. The regulatory change was required by Chapter 1207 of the 2020 Acts of Assembly (Act). The Act added "coastal resilience and adaptation to sea-level rise and climate change" to the criteria to be used by local governments and required that the Board adopt regulations to implement the provision. Mr. Williams presented the goals of the amendments, summary of the final changes to the regulation, including the addition of climate adaptation to measures allowed in CBPA Areas and conditions, the requirement that localities consider specific climate change impacts in proposed land development, and language to address the overlap with requirements from floodplain management and Virginia Marine Science Commission regarding wetlands.

Mr. Williams then completed the presentation providing a summary of the comments received during the Notice of Public Comment which ran from 2/1/21 - 5/3/21, along with the DEQ responses and the certification received from the Attorney General's Office that the Board had the authority to adopt the amendments. Twelve speakers then addressed the Board. Seven speakers, representing two localities, a Planning District Commission, along with a four organizations, primarily requested additional time for the Stakeholder Advisory Group to meet for clarification or minor changes to final amendments. The remaining speakers represented organizations supporting final adoption of the amendments as presented.

Decision:

Based upon the information provided to the Board and the staff recommendation, the Board approved, by a vote of 6-0 (all present) the following action:

 Adopt the final amendments to the CBPA Designation and Management Regulation at 9 VAC25-830-10, as presented.

MINUTE 9 — Chesapeake Bay Preservation Area Designation and Management Regulation - 9VAC25-830 - Final Amendment - Preservation of Mature Trees and Replanting of Trees

Justin Williams, Office of Watershed and Local Government Assistance Programs, presented final amendments to the Chesapeake Bay Preservation Area (CBPA) Designation and Management Regulation. The regulatory change was required by Chapter 1207 of the 2020 Acts of Assembly (Act The Act added "preservation of mature trees or planting of trees as a water quality protection tool and as a means of providing other natural resource benefits" to the criteria to be used by local governments and required that the Board adopt regulations to implement the provision. Mr. Williams presented a summary of the proposed changes to the regulation, including the definition of mature trees, addition of preserving mature trees and tree planting in existing vegetation requirements, and recognition of existing ordinances related to tree planting and preservation to demonstrate compliance with the new requirements in certain CBPA areas.

Mr. Williams then completed the presentation providing a summary of the comments received during the Notice of Public Comment which ran from 2/1/21 - 5/3/21, along with the DEQ responses and the certification received from the Attorney General's Office that the Board had the authority to adopt the amendments. Ten speakers then addressed the Board. Six speakers representing two localities, along with four organizations, primarily requested additional time for the Stakeholder Advisory Group to meet for clarification or minor changes to final amendments. The remaining speakers represented organizations supporting final adoption of the amendments as presented.

Decision:

Based upon the information provided to the Board and the staff recommendation, the Board approved, by a vote of 6-0 (all present) the following action:

 Adopt the final amendments to the CBPA Designation and Management Regulation at 9 VAC25-830, as presented.

MINUTE NO. 12 - Water Permitting Division Director's Report

Ms. Melanie D. Davenport provided an update on the Mountain Valley Pipeline project. She provided updates on (i) the construction status of the project and (ii) the status of MVP's application for a Virginia Water Protection permit and request for Section 401 water quality certification.

She also reported on the status of a number complaints/investigations that DEQ responded to during the period including: DCR's inspection of trench excavation as it proceeds through the karst terrain in Giles County; DCR and DEQ's continuing to negotiations with the Sink family on the details of a proposed investigation of possible karst-related sediment intrusion into Bottom Spring; DEQ's meeting with Franklin County erosion and sediment program staff and property owner at the Angle property to investigate a flood-damaged temporary bridge over Little Creek that was a concern to the County; DEQ's meeting with representatives of Dominion at its Maplewood Solar site under construction in Pittsylvania County to ensure potential conflicts between MVP and Maplewood are avoided; DEQ's review of redline documentation for an access road on the Hamm/Vest property (MVP-RO-286) prepared in response to onsite meeting with landowner.

Finally, Ms. Davenport reported that DEQ is currently reviewing compliance data for the March 11, 2021 – June 10, 2021 monitoring period under the existing consent decree; that FERC is evaluating MVP's proposal to change the crossings methods for some waterways and wetlands from open cut to trenchless and will issue an Environmental Assessment of the proposal by August 13 and a final decision by November 11, 2021; and on March 4, 2021, the U.S. Department of Justice notified MVP that it had concluded its investigation without an adverse determination. US EPA Criminal Investigation Division closed their investigation of MVP on January 29, 2021.

Following the Director's report, Mr. Hayes recommended that at future meetings, a report on MVP be included on the regular agenda. He suggested that this report does not need to include construction status but should focus on complaints and investigations.
