### Summary

Currently, regulations of the Board of Physical Therapy provide for a fee of \$25 for a check that is not paid by a financial institution on which it is drawn because of insufficient funds in the account. The Administrative Process Act specifies that the penalty shall be \$35 or the amount of any costs, whichever is greater.

*§ 2.2-614.1. Authority to accept revenue by commercially acceptable means; service charge; bad check charge.*

*...C. If any check or other means of payment tendered to a public body in the course of its duties is not paid by the financial institution on which it is drawn, because of insufficient funds in the account of the drawer, no account is in the name of the drawer, or the account of the drawer is closed, and the check or other means of payment is returned to the public body unpaid, the amount thereof shall be charged to the person on whose account it was received, and his liability and that of his sureties, shall be as if he had*

*never offered any such payment. A penalty of \$35 or the amount of any costs, whichever is greater, shall be added to such amount. This penalty shall be in addition to any other penalty provided by law, except the penalty imposed by § 58.1-12 shall not apply.*

Accordingly, the Board has adopted an amendment under an exempt action to conform regulations to the statute. Although required to comply with the Virginia Register Act, the agency is exempt from provisions of the Administrative Process Act for the implementation of these regulations pursuant to § 2.2-4006 A 4, which grants an exemption if the action is: “Necessary to conform to changes in Virginia statutory law or the appropriation act where no agency discretion is involved.”

Additionally, the Board has acted to reconcile the renewal procedure currently listed in section 130 with the fee regulations and the procedure of the Board. Previously, the Board of Physical Therapy amended section 135 to change the renewal from a licensee's birth month to renewal for all licensees on December 30th. That change became effect on October 19, 2005. At that time, the agency failed to amend the same language in section 130 for a biennial renewal. At the Board’s last meeting, that was corrected to be consistent with the fee section to avoid a conflict and confusion by licensees. Although required to comply with the Virginia Register Act, the agency is exempt from provisions of the Administrative Process Act for the implementation of these regulations pursuant to § 2.2-4006 A 2, which grants an exemption if the regulations “establish or prescribe agency organization, internal practice or procedures, including delegations of authority.”

On January 27, 2006, the Board of Physical Therapy adopted exempt actions to Chapter 20, Regulations Governing the Practice of the Board of Physical Therapy to amend the returned check fee regulations to conform to § 2.2-614.1 of the Code of Virginia and to correct the procedure for renewal listed in section 130.
