Chapter 82 of the 2016 General Assembly requires health regulatory boards to promulgate regulations to allow some volunteer service time to count towards meeting some of a licensee's continuing education requirements.

The Board has adopted proposed regulations to allow physical therapists and physical therapist assistants to count two hours of the Type 2 hours allowed for renewal to be satisfied through delivery of professional services, without compensation, to low-income individuals receiving

health services through a local health department or a free clinic organized in whole or primarily for the delivery of those services. One hour of continuing education may be credited for one hour of providing such volunteer services, as documented by the health department or free clinic.

On November 15, 2016, the Board of Physical Therapy adopted amendments to 18VAC112-20-10 et seq., Regulations Governing the Practice of Physical Therapy.

Regulations are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Section 54.1-2400, which provides the Board of Physical Therapy the authority to promulgate regulations to administer the regulatory system and a specific mandate of Chapter 82 of the 2016 General Assembly:

§ 54.1-2400. General powers and duties of health regulatory boards.

The general powers and duties of health regulatory boards shall be:

1. To establish the qualifications for registration, certification, licensure or the issuance of a multistate licensure privilege in accordance with the applicable law which are necessary to ensure competence and integrity to engage in the regulated professions.
2. To examine or cause to be examined applicants for certification or licensure. Unless otherwise required by law, examinations shall be administered in writing or shall be a demonstration of manual skills.

- 3. To register, certify, license or issue a multistate licensure privilege to qualified applicants as practitioners of the particular profession or professions regulated by such board.
- 4. To establish schedules for renewals of registration, certification, licensure, and the issuance of a multistate licensure privilege.
- 5. To levy and collect fees for application processing, examination, registration, certification or licensure or the issuance of a multistate licensure privilege and renewal that are sufficient to cover all expenses for the administration and operation of the Department of Health Professions, the Board of Health Professions and the health regulatory boards.
- 6. To promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) *that are reasonable and necessary to administer effectively the regulatory system, which shall include provisions for the satisfaction of board-required continuing education for individuals registered, certified, licensed, or issued a multistate licensure privilege by a health regulatory board through delivery of health care services, without compensation, to low-income individuals receiving health services through a local health department or a free clinic organized in whole or primarily for the delivery of those health services.* Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.).

Purpose

The purpose of the amended regulation is compliance with the mandate of the General Assembly and to provide an incentive for licensees to volunteer professional services to free clinics or public health centers. While a licensee can satisfy two hours of Type 2 continuing education with hours of volunteer service, he or she is still required to have 20 Type 1 hours of approved continuing education for physical therapists and 15 Type 1 hours for physical therapist assistants necessary to acquire new knowledge and skills. Therefore, public health is served by a potential increase in badly-needed volunteer service for health care; but public safety is not sacrificed by eliminating most or all of the continuing education hours required for renewal.

Rationale for using fast-track process

The allowance of hours for volunteer service to be counted towards the continuing education requirement is a mandate of the General Assembly. A licensee is not required to provide

volunteer service but may be credited with continuing education hours for doing so. The provision is permissive and not controversial.

To comply with the mandate of Chapter 82 of the 2016 General Assembly, the Board has adopted a proposed regulation to allow physical therapists and physical therapist assistants to count two hours of the Type 2 hours allowed for renewal to be satisfied through delivery of professional services, without compensation, to low-income individuals receiving health services through a local health department or a free clinic organized in whole or primarily for the delivery of those services.

Issues

- 1) The advantage to the public is the incentive given for licensees to volunteer their services in exchange for credit towards meeting continuing education requirements. There are no disadvantages.
- 2) There are no advantages or disadvantages to the agency or the Commonwealth.
- 3) The Director of the Department of Health Professions has reviewed the proposal and performed a competitive impact analysis. The Board is authorized under 54.1-2400 to "*promulgate regulations in accordance with the Administrative Process Act (§ 9-6.14:1 et seq.) which are reasonable and necessary to administer effectively the regulatory system.*" There is no restraint on competition as a result of promulgating this regulation.

Given that the Board has a statutory mandate to promulgate a regulation for CE credit for volunteer hours, it selected the alternative that would achieve the essential purpose of encouraging volunteering while not substantially reducing the amount of continuing education necessary to improve and maintain competency.

18VAC112-20-131	Sets out the requirements for continuing education for renewal of an active license	<p>Subsection B in section is amended as follows:</p> <p><u>Up to two of the Type 2 continuing education hours may be satisfied through delivery of physical therapy services, without compensation, to low-income individuals receiving services through a local health department or a free clinic organized in whole or primarily for the delivery of health services.</u></p> <p><i>The intent of the Board was to comply with a statutory mandate to allow credit for volunteer hours. The criteria and settings for such volunteer services are specified in § 54.1-2400 (6). If a licensee volunteers at a local health department or free clinic, he or she would be able to satisfy two of the Type 2 hours of continuing education.</i></p> <p><i>Physical therapists are allowed to satisfy no more than 10 of the 30 hours required for biennial renewal with Type 2 hours. Physical therapist assistants are allowed to satisfy no more than 15 of the 30 hours with Type 2 hours. Type 2 is defined as meaning continuing learning activities which may or may not be offered by an approved organization but shall be activities considered by the learner to be beneficial to practice or to continuing learning.</i></p> <p><i>Therefore, all of the Type 1 hours would continue to be required, and a maximum of two of the Type 2 hours could be credited for volunteer practice.</i></p>
