The Board of Optometry proposes to add the requirement to include an NPDB report to licensure by endorsement provisions for protection of the public. The NPDB records all actions taken in other jurisdictions against a healthcare licensee and is a standard requirement on applications for licensure and licensure by endorsement for many other professions, including: Dentistry (18VAC60-21-90(A)(3); 18VAC60-25-130(A)(3)); Medicine (18VAC85-20-141(5) (physicians and podiatrists); Long-Term Care Administrators (18VAC95-20-230(B)(5) (nursing home administrators) and 18VAC95-30-130(B)(5) (assisted living facility administrators)); Physical Therapy (18VAC112-20-65(B)(3) (applies to physical therapists and physical therapist assistants)); Counseling (18VAC115-20-45(A)(6) (licensed professional counselors), 18VAC115-30-45(4) (certified substance abuse counselors and assistants), 18VAC115-40-25(5) (certified rehabilitation providers), 18VAC115-50-40(A)(6) (licensed marriage and family therapists), 18VAC115-60-50(7) (licensed substance abuse treatment providers), 18VAC115-70-40(A)(2) (registered peer recovery specialists), 18VAC115-80-40(A)(2) and 18VAC115-80-50(A)(2) (qualified mental health providers)); Psychology (18VAC125-20-42(5) (licensed clinical, school, and applied psychologists) and 18VAC125-30-30(A)(3)(c) (certified sex offender treatment providers)); and Social Work (18VAC140-20-40(2)(e) (licensed clinical social workers) and 18VAC140-20-51 (B)(2)(c) (licensed masters social workers and licensed bachelors social workers)).

Regulations of the Board of Optometry are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be "[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system."

The purpose of the action is to add a requirement to submit a current NPDB report with an application for licensure for endorsement. This is necessary for protection of the public because the NPDB, operated by the U.S. Department of Health and Human Services, is a clearinghouse for medical malpractice payment

and adverse action reports on healthcare professionals in all jurisdictions of the United States. It is an invaluable resource when determining whether an applicant is safe and competent to practice optometry in the Commonwealth.

The Board will amend 18VAC105-20-10 to require that every applicant for licensure by endorsement submit a current report from the U.S. Department of Health and Human Services National Practitioner Data Bank.
