## Fast-Track Regulation Agency Background Document

This fast-track action repeals 18VAC110-140 and 18VAC110-150, as these sections of regulation are outdated and contradictory of the Code. These sections were replaced in regulation by 18VAC110-141 but were not removed, leaving the Board regulations that do not serve a purpose.

On March 30, 2023, the Board of Pharmacy voted to amend the Regulations Governing the Licensure of Pharmacists and Registration of Pharmacy Technicians.

The impetus for this action is the expiration of these regulations during the approval process.

Regulations of the Board of Pharmacy are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be “[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system.”

The purpose of this fast-track action is to remove regulations that are no longer needed. The Board has determined that the regulations to be deleted are outdated as written and were made obsolete by changes in statute.

The Board voted to repeal 18VAC110-140 and 18VAC110-150.

- 1) The primary advantages to the public are the removal of outdated regulations will alleviate confusion about the meaning and intent of the regulations. There are no disadvantages to the public.

Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.) of this title.” The promulgated regulations do not conflict with the purpose or intent of Chapters 1 or 25 of Title 54.1.

The alternative would be to do nothing, as the Code would supersede these regulations. However, to provide the most clarity for practitioners, removing the sections of regulation is a simple regulatory change that will reduce the overall number of regulations published related to pharmacy technician trainees.
