This regulatory action will result in the promulgation of the regulation required by Chapter 319 of the 2016 Acts of Assembly. Chapter 319 of the 2016 Acts of Assembly requires the Board of Agriculture and Consumer Services (Board) to adopt a regulation for use in determining whether a private animal shelter meets the purpose of finding permanent adoptive homes for animals.

Section 3.2-109 of the Code of Virginia establishes the Board of Agriculture and Consumer Services as a policy board.

Chapter 319 of the 2016 Acts of Assembly requires the Board to promulgate the regulation described in this notice of intended regulatory action.

Purpose

Chapter 492 of the 2015 Acts of Assembly amended the definition of a private animal shelter in the Virginia Comprehensive Animal Care Law (Va. Code § 3.2-6500 *et seq.*) to require that a facility that seeks to be a private animal shelter operate for the purpose of finding permanent adoptive homes. In the year that followed, there was significant debate among stakeholders as to what determines this purpose. This debate continued into the 2016 Session of the General Assembly. Consequently, Chapter 319 of the 2016 Acts of Assembly requires the Board to adopt a regulation for use in determining whether a private animal shelter meets the purpose of finding permanent adoptive homes for animals. The agency expects this issue will remain contentious and may result in considerable public comment.

Substance

The proposed regulation will consist of criteria for use in determining whether a private animal shelter meets the purpose of finding permanent adoptive homes for animals.
