The Virginia Marine Resources Commission (VMRC) is amending Chapter 4 VAC 20-950-10 et seq., "Pertaining to Black Sea Bass", to open a recreational black sea bass season in February 2023.

[Mandate] VMRC is authorized by § 28.2-201 of the Code of Virginia to promulgate regulations and guidelines necessary to carry out the provisions of Title 28.2, including marine fisheries regulations and 28.2-210 for emergency regulations.

[Impetus] Since 2018, the National Marine Fisheries Service has opened federal waters for a recreational black sea bass fishery in February under the condition that any state participating must pay back their February landings during the regular May through December recreational season. In 2020, ASMFC and MAFMC said they support continuing the February recreational season option for states. In October 2022, the Finfish Management Advisory Committee (FMAC) passed a motion to pursue the February black sea bass season in 2023 in recognition of its popularity and importance to the for-hire industry. On December 13, 2022, ASMFC approved Virginia's proposal for a February 2023 recreational season.

§ 28.2-210, If, in an emergency, the adoption of a regulation is necessary for the immediate preservation of the public peace, health, safety, and welfare, or the protection of the seafood industry, natural resources or marine organisms, the Commission may promulgate the necessary regulation. The regulation shall be published and filed as prescribed in § 28.2-209. No regulation adopted as an emergency regulation shall remain in effect longer than thirty days unless a public hearing is held as required in § 28.2-211 after being advertised as prescribed in § 28.2-209.

Purpose

Harvest seasons are time sensitive to natural resources of the Commonwealth that have short windows for the industry and public to efficiently use the resource. This is an emergency regulation due to a missed deadline for the public notice. It is eligible for the emergency regulation based on §28.2-210 which states that the Commission may promulgate emergency regulations for protection of the seafood industry. The regulation will sunset thirty days from its effective date, which will be after the February season has already closed.

4VAC20-950-45. Recreational possession limits and seasons.

Any person fishing recreationally to harvest or possess any black sea bass from February 1 through February 28, 2023, must obtain a Recreational Black Sea Bass Permit from VMRC to participate in the open February season passed by emergency.

Issues

Since 2018, the National Marine Fisheries Service has opened federal waters for a recreational black sea bass fishery in February under the condition that any state participating must pay back their February landings during the regular May through December recreational season. States must request this special season and be approved by the ASMFC as well as have an approved payback plan. On December 13, 2022, ASMFC approved Virginia's proposal for a February 2023 recreational season.

Virginia participated in this special recreational season from 2018 through 2021 with the understanding that any additional landings occurring in February each year would result in a deduction of fishing days from the open season. Permit holders (the captain or operator of the vessel) were required to report to the commission the number of trips they took, the number of anglers on board, and the number of black sea bass they landed and released. Permit holders were also required to call the Marine Police Operations Stations before each trip so VMRC staff could arrange to sample a subset of trips for fish lengths and weights.
