SUBJECT: Handling Milk and Dairy Product Complaints

Some confusion has been expressed over handling complaints involving milk and dairy products. This document sets forth the procedure for investigating such complaints. The format of the document is that which has been developed for all entries into the Division's Program Implementation Manual.

Please insert this document in your PIM manual and distribute copies to all persons in your district working in your foodservice protection program. Please note that the PIM is effective July 1, 1997.

Program: Foodservice Protection

Subject: Milk and Dairy Complaints

Objective: The goal of statewide foodservice protection services is the prevention of

foodborne illness. Our effectiveness in this pursuit is dependent upon the timely

response to food complaints initiated by the public.

Authority: The authority for issuing this guideline is as follows:

Code of Virginia

- 1. §3.1-361 through 419 Food and Drink
- 2. §3.1-530.1 through 530.9 Milk, Milk Products, and Dairy Standards of Quality, Grading, Sanitary Standards, Etc.

Other

1. Memorandum of Understanding Between the Virginia Department of Agriculture and Consumer Services (VDACS) and the Virginia Department of Health (VDH).

Background: There has been some confusion as to the handling of Grade A Milk product

complaints. This document standardizes procedures for investigating milk

complaints.

Procedures: 1) The recipient of the complaint should follow the **PROCEDURES FOR**

PROCESSING DAIRY PRODUCTS COMPLAINTS. (Attached)

2) The Recipient of the complaint should refer to the enclosed list of **Health Districts with Milk Plants** to determine which district is responsible for investigating the complaint and refer the complaint to that district Environmental Health Manager or Environmental Health Milk Specialist.

3) Depending on the nature of the complaint, the district receiving the complaint

shall investigate any aspect of the complaint that is under their regulatory authority. For example, if the complaint involves milk purchased from a restaurant, the local health department shall investigate the milk handling procedures of the restaurant.

4) The district that initially received the complaint will keep a record of the complaint until they receive notice of its final disposition from the investigating department.

Responsibility: The District Environmental Health Manager is responsible for the implementation of these procedures by the district foodservice protection and milk sanitation staff. Local milk environmental health specialists seniors are responsible for documenting the investigation results.

ATTACHMENT 1

PROCEDURE FOR PROCESSING DAIRY PRODUCT COMPLAINTS

When a dairy product complaint is received, the standard complaint form should be completed. The form should be as complete as possible with all necessary information to perform a proper investigation. The recipient of the complaint should inform the complainant of the complaint disposition (i.e., "Your complaint will be handled by..." or "Your complaint will be forwarded to..."). Complaints involving out of state dairies should be forwarded to the Division of Food and Environmental Services.

The following information should be included on the record of complaint:

- 1. **Product Identification:** Complete name of product as it appears on the container, the type and size of container. (Example: 12 oz. sour cream or 6 oz. container of half & half, etc.).
- 2. <u>Container Codes</u>: Embossed plant code and other embossed information or a manufacturer's plant code if printed on carton (should be one or the other). Also, the expiration date, a one or two-line code embossed or stamped on the container (Example: Exp. 4-12-98). We do NOT need the Uniform Product Code (a list of numbers found below a group of various width bars).
- 3. **Retail Source**: Complete name and address of the retail outlet where product was purchased.
- 4. <u>Manufacturer</u>: The plant that actually manufactured the product, not the company which distributed the product. If this information is not readily available, get the distributor information for the product. Include the zip code as it appears on the container.
- 5. **Date Purchased**: The approximate date the product was purchased.
- 6. <u>Nature of Complaint</u>: Specifics about the product characteristics, i.e., detail exactly what the problem with the product is. If an illness is involved, how long after consuming the product before the onset of the illness, the nature of the illness (fever, pain, vomiting, diarrhea, etc.), duration of illness, etc. Was a doctor seen? (If so, who, when, address, phone number, nature of treatment, diagnosis, etc.). If hospitalized, (where, when, address, length of time, when released, etc.) If the dairy product was contaminated, indicate the nature of the contamination (color, size, and type of object, or odor, taste, etc.).

A copy of the complaint shall be sent to the health district where the processing plant is located. The health district where the processing plant is located will send a copy of the complaint to the processing plant that produced the product for investigation and resolution. In most cases, we are not interested in acquiring the remaining product. The milk processing plant producing the

product will make arrangements to contact the complainant and collect the dairy product.
