Further, the regulation is necessary to ensure that the Board's statutory requirements are executed in the least burdensome, most efficient and cost effective manner possible while protecting the health, safety, and welfare of the citizens of Virginia.

Section 54.1-501 mandates the Board to promulgate regulations and standards for the training and licensing of asbestos workers, supervisors, inspectors, management planners, project designers and project monitors. Therefore, the continued need for the regulation is established in statute. The regulation is necessary to protect public health, safety and welfare and ensure that individuals licensed as asbestos workers, supervisors, inspectors, management planners, project designers and project monitors have met minimum competencies. No complaints and only two comments were received during the public comment period. One comment was in support of the regulation and a mechanism is already in place to address the concern in the second comment received. Therefore, there does not appear to be a reason to amend or repeal the regulation. The regulation is clearly written and easily understandable. The regulation does not overlap, duplicate or conflict with federal or state law or regulation. The most recent periodic review of the regulation occurred in 2008 and resulted in amendments to the asbestos contractor responsibilities section and established project monitor responsibilities. The Board discussed and, for the reasons stated in this section, determined that the regulation should not be amended or repealed, but should be retained in their current form.
