The alternative considered was to have no regulation at all. Without the records required by this regulation, the agency would be unable to assist in ensuring that farmers receive prompt

payment for their grain. The required records provide an accounting in the event of default by the grain dealer, which helps farmers document and get paid for their losses.

This regulation specifies the information that must be recorded by grain dealers in grain transactions with farmers. Without the records required by this regulation, the agency would be unable to assist in ensuring that farmers receive prompt payment for their grain. The records provide an accounting of amounts owed in the event of non-payment of grain by the grain dealer. In many cases, these transactions are for large amounts of money. Therefore, this regulation implements a law that helps to protect farmers from the loss of income and supports their economic welfare. This regulation is clearly written and easily understandable.

The agency is recommending that the regulation should stay in effect without change for the economic welfare of Virginia grain producers.
