Further, for violation of Count 1, **Bigford Enterprises Inc.** agrees that a member of Responsible Management shall successfully complete a Board-approved remedial education class.

**Consent Order Process**

**Bonnie Rhea Adams, CAR Director Compliance Manager** shared with the Board members some information concerning the Consent Order Process and how it works. **Michelle Couch, Lead Legal Analyst** and **Sarah Towel, Legal**

Analyst were available to answer questions. The Board thanked the team for the presentation and shared that the information was enlightening.

### **Experience requirements for – Tradesman and Qualified Individuals**

After much discussion the Board decided to table experience requirements until the August 2<sup>nd</sup>, 2016 meeting.

### **Installation of fences – licenses requirements and Integrity Update – Financial Statement**

There was much discussion and following the discussion a motion was offered by Oliver and seconded by Middleton for the Board to adopt the following:

- 1) If the assets of an applicant contain more than 24% undocumented value (accounts receivable, “other”, etc.) then the applicant must provide an audited financial statement or not count more than 25% of that value when calculating the net worth.
- 2) In order for an applicant to qualify for an “umbrella” specialty (HIC or CIC) then they must have experience in at least three of the “breakout” specialties. For example, an applicant with experience in flooring, painting, and roofing, would be eligible for the applicable improvement specialty. However, an applicant with only flooring and painting, would be required to hold the PTC and FLR specialties. The “breakout” specialties are: DRY, FIN, FLR, GLZ, INS, BRK, PTC, ROC, TMC, and FRM.
- 3) Landscape services contractor are now permitted to install fencing that is not required by statute or regulation, which would be about 99% of the fences that we see in the residential market. A fence that would be required by statute or regulations would be one that surrounds a swimming pool, or one that is around an electrical substation or one that is around a hazardous material structure.

The motion passed with a unanimous “yes” vote. Members voting “yes” were: **Dowdy, Hux, Dyer, Magruder, Middleton, Oliver, Pace, Redifer and Smith. Ayres, Mitchell, Giesen, O’Dell, Trenary, and Chowdhuri were absent.**

### **Remedial Education**


