Mr. Cuffee was present and addressed the Board. Mr. Vander Pol moved to accept the summaries and recommendations of the Presiding Officer with a correction to the Informal Fact-Finding Summary for 2012-00328, page three, number 4, last sentence, the language should read a licensed asbestos supervisor instead of a licensed lead worker and in both of the files in the Informal Fact-Finding Summaries a correction, page three, number 8, after the first sentence, the phrase "Cuffee is" should be deleted, and approve Mr. Cuffee's asbestos supervisor application and lead worker application. Mr. Marston seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Koepf, Loving, Marston, Palmer, and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Marston made a motion to adopt the staff recommendation and that the Board require Board-approved initial training, approved on or after July 1, 2011, to satisfy the entry requirements found at 18 VAC 15-60-40.A.4 for any individual applying for licensure. Further, that since the CEI course completed in October 2009 by ACM employees did not include the required six hours of hands-on

training, the Board requires that those ACM employees applying for a mold remediator worker license under 18 VAC 15-60-40.A.4.a. complete Board-approved initial training that was approved on or after July 1, 2011 before being eligible for licensure. Mr. Loving seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Koepf, Loving, Marston, Palmer and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Vander Pol moved that because no public comment was received during the public comment period on the Board's Public Participation Guidelines regulation, the Lead-Based Paint Activities regulation, and the Certified Home Inspectors regulation, the Board will retain the Public Participation Guidelines regulation, the Lead-Based Paint Activities regulation, and the Certified Home Inspectors regulation in their current form. Mr. Chapman seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Fincher, Koepf, Loving, Marston, Palmer, and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Loving moved that the Board adopt the summary of public comment and agency response to the comments received on the Asbestos Licensing regulation during the public comment period, that the comments presented no information justifying an

amendment to the Asbestos Licensing regulations and, therefore, the Board will retain the Asbestos Licensing regulation in its current form. Ms. Becker seconded the motion which was unanimously approved by: Atwood, Chapman, Cronan, Daniels, Fincher, Koepf, Loving, Marston, Palmer and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

Mr. Palmer moved that the Board adopt the summary of public comment and agency response to the comments received on the Mold Inspector and Remediator regulation, that the comments presented no information justifying an amendment to the Mold Inspector and Remediator regulation, and, therefore, the Board will retain the Mold Inspector and Remediator regulation in its current form. Mr. Chapman seconded the motion which was unanimously approved by: Atwood, Chapman, Cronan, Daniels, Fincher, Koepf, Loving, Marston, Palmer, and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations.

The Board briefly discussed the Code of Virginia definitions of “mold inspection” and “mold remediation” as they applied to certain work performed by mold inspectors and mold remediators. Specifically, the Board was concerned that mold remediators may be presenting their remediation proposal or scope of work to potential clients as a mold management plan or a mold remediation protocol, which may only be prepared by a licensed mold inspector.
