- 2) Proof of compliance as referenced in provision one may include but is not limited to documentation from staff of the Sex Offender Registry of the State of Maryland and/or any documentation deemed appropriate by the Board,
  - 3) Any and all other conditions deemed appropriate by the Board.

Mr. Chapman, the second, agreed to the amendment.

After further discussion, Mr. Vander Pol moved to further amend his motion to approve Mr. Herrera's application for a mold remediator supervisor license subject to the terms of an Agreement for Licensure wherein Mr. Herrera agrees to the following condition within 14 days: Provide documentation to the Board that he has registered with the Virginia Sex Offender and Crimes Against Minors Registry or provide documentation that he is not required to register with the Virginia Sex Offender and Crimes Against Minors Registry. The documentation is to accompany his signed Agreement for Licensure. Mr. Chapman, the second, agreed to the amendment. The amended motion was approved by 8 "yes" votes from Chapman, Cronan, Daniels, Hyatt, Loving, Marston, and Vander Pol and 3 "no" votes from Atwood, Palmer, and Koepf. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated to RRP until the effective date of the regulations. Board member Blevins was absent and did not vote.

The Board recessed for a break from 9:48 a.m. and reconvened at 10:02 a.m.

Mr. Vander Pol made a motion that based on House Bill 1291 and Senate Bill 678 having been signed by the Governor that the Board authorize Board staff to file an exempt action, to be effective on July 1, 2012, to repeal the Board for Asbestos, Lead, Mold, and Home Inspector Mold Inspector and Remediator Regulations. Mr. Chapman seconded the motion which was unanimously approved by members: Atwood, Chapman, Cronan, Daniels, Hyatt, Koepf, Loving, Marston, Palmer and Vander Pol. Board members Colleen Becker, Rick Holtz and Kenneth Nash were present but did not vote because, by statute, they are ineligible to vote on matters unrelated

Mr. Dick provided the Board with a handout as a response to their request that staff provide statistics on the number of initial applications, renewal applications and the regulant population for the Board to consider at this meeting. Mark Courtney, Deputy Director of Licensing and Regulation, shared with the Board that any individual who paid for the processing of a mold license application will receive a refund of the \$25.00 application fee. A letter will accompany the refund.

David Dick shared that the Board's regulations remain in the Governor's office awaiting approval. No additional information is available at this time. The Board took no action.
